WHEREAS, the Tuguegarao City Government recognizes individuals who have brought recognition and honor, worthy of admiration and emulation.



RESOLVED FURTHER, to furnish a copy of this resolution to **PCPT MICHELLE C. SORIANO**, for his information.


On motion of Hon. Soriano, duly seconded by Hon. Arago, **CITY RESOLUTION NO. 102-09-2024** was **APPROVED**.
