RESOLUTION CONCURRING THE MEMORANDUM OF AGREEMENT BETWEEN THE TUGUEGARAO CITY GOVERNMENT AND DR. JANET CANAY-RIVERA, VISITING CONSULTANT/SPECIALIST AT THE TUGUEGARAO CITY PEOPLE’S GENERAL HOSPITAL

WHEREAS, Section 22(c) of Republic Act No. 7160, otherwise known as the Local Government Code, grants the power to the Local Chief Executive to enter into contracts on behalf of the local government unit with prior authorization by the Sanggunian concerned;

WHEREAS, the Ninth City Council in its 19th Regular Session held on November 22, 2022 approved City Ordinance No. 61-09-2022 titled “*An Ordinance Granting Continuing Authority to the City Mayor for and on Behalf of the Tuguegarao City Government to Enter into a Memorandum of Agreement with Visiting Consultants/Specialists of Tuguegarao City People’s General Hospital*”;

WHEREAS, the City Mayor, Hon. Maila Rosario S. Ting-Que, requested the Ninth City Council for concurrence of the Memorandum of Agreement between the Tuguegarao City Government and Dr. Janet Canay-Rivera, Visiting Consultant/Specialist, with specialty in Anesthesia at the Tuguegarao City People’s General Hospital on March 23, 2023 which was included in the Agenda of the 37th Regular Session held on March 28, 2023;


