The committee met and deliberated on the referral:

**COMMITTEE REPORT NO. 104-2024**

**SUBJECT:**

Indorsement of the City Mayor, Hon. Maila Rosario S. Ting-Que, on the request of Ms. Elizabeth G. Dupaya of Dupaya Recreation Center to hold Special Derbies on various dates of May 2024.

**FINDINGS:**

1. Hon. Maila Rosario S. Ting-Que indorsed to the Ninth City Council the request of the Dupaya Recreation Center to hold special derbies on the various dates of May 2024.
2. Section 10 Paragraph D of the City Ordinance No. 32-08-2019 states that the City Mayor may issue permits for special cockfights, cock or stag derbies including cockfights via satellite participated in by cockers and breeders through invitations upon application duly approved by the Sangguniang Panlungsod through resolution **30-working days** before the scheduled playdate.
3. Upon deliberation of the said request, the committee approved the following scheduled play dates:

May 06, 2024

May 08, 2024  
May 13, 2024  
May 15, 2024  
May 20, 2024  
May 22, 2024  
May 27, 2024 &  
May 29, 2024 only

However, the committee did not approve May 01, 2024 from the list of the said scheduled play dates, in accordance to the celebration of the National Labor Day.


4. The Dupaya Recreation Center, Inc. should use traditional betting during its Special Derbies.

**RECOMMENDATION:**

After a thorough discussion on the requested scheduled play dates of the Dupaya Recreation Center, Inc., the committee, without further objections from its members, recommends the conduct of special derbies on May 06, 08, 13, 15, 20, 22, 27, & 29 only along with the use of traditional betting during the said special derbies and subject to the final approval of the Ninth City Council in plenary.
