COMMITTEE REPORT NO. 104-2025

SUBJECT:

Letter of the Owner/Operator of the Dupaya Recreation Center, Ms. Elizabeth G. Dupaya, requesting for the reconsideration of City Resolution No. 210-09-2025 denying the request of scheduled playdates of the Dupaya Recreation Center for the month of June 2025.

FINDINGS:

1. City Ordinance No. 32-08-2019 titled "***AN ORDINANCE AMENDING ORDINANCE NO. 08-2005, OTHERWISE KNOWN AS THE TUGUEGARAO CITY REVISED COCKFIGHTING ORDINANCE OF 2005***".
2. The above ordinance contains no provision prohibiting the conduct of special cockfights every month.

3. Section 10 Paragraph D of the City Ordinance No. 32-08-2019 states that the City Mayor may issue permits for special cockfights, cock or stag derbies including cockfights via satellite participated in by cockers and breeders through invitations upon application duly approved by the Sangguniang Panlungsod through resolution **30-working days** before the scheduled playdate and the City Ordinance also states that the authority to hold special cockfights or derbies and Barangay sponsored cockfights should always be covered by a Resolution of the Sangguniang Panlungsod and the Mayor's Permit.
4. The committee did not consider the scheduled playdates to hold special cockfights on June 02 and 04, 2025 considering of its violation on the above provision of the Ordinance.

RECOMMENDATION:

After a thorough discussion and finding the request to be advantageous to the Tuguegarao City Government, the joint committees recommend the approval of the reconsideration of City Resolution No. 210-09-2025.

The joint committees further recommend the approval of the following playdates on June 9, 11, 16, 18, 23, 25 and 30, 2025 and denial of June 2 and 4, 2025 playdates.
