WHEREAS, the abovementioned student athletes have made Tuguegarao City proud by virtue of their achievements, truly worthy of the Tenth City Council's commendation;




RESOLVED FINALLY, to furnish a copy of this Resolution to University of Saint Louis Tuguegarao for information.
