## COMMITTEE REPORT NO. 106-2025

#### SUBJECT:

Indorsement of the City Mayor, Hon. Maila Rosario S. Ting-Que, on the letter of the President of Goldsmith Gaming Corporation with the legal opinion of the City Legal Officer, Atty. Roderick S. Iquin, relative to the request for amendment of Resolution of No Objection (RONO) previously granted to the corporation.

### **FINDINGS:**

- Hon. Maila Rosario S. Ting-Que indorsed to the Ninth City Council the letter of the President of Goldsmith Gaming Corporation with the legal opinion of the City Legal Officer, Atty. Roderick S. Iquin, relative to the request for amendment of Resolution of No Objection (RONO) previously granted to the corporation.
- 2. The Goldsmith Gaming Corporation respectfully seeks approval to expand its electronic gaming operations to include all PAGCOR-approved games, including traditional and electronic bingo, as part of its commitment to enhance service offerings to its clientele. Furthermore, the Corporation is requesting the transfer of its business operations from its current location at Unitop Balzain to MEES Shopping Center, situated at the corner of Luna

and Taft Streets. The proposed new location remains within the appropriate jurisdiction and is fully compliant with all applicable zoning and regulatory requirements.

- 3. Atty. Roderick S. Iquin, City Legal Officer has recommended that the proposed expansion and relocation are consistent with both local and national regulations and in alignment with the policies established by the Philippine Amusement and Gaming Corporation (PAGCOR). He further emphasized that the initiative is expected to generate additional local revenue, create employment opportunities, and stimulate economic activity in the vicinity of the new location.
- 4. The members of the committee have expressed their concurrence with the aforementioned recommendation.

WHEREAS, the City Mayor, Hon. Maila Rosario S. Ting-Que, indorse to the 9<sup>th</sup> City Council, letter of the President of Goldsmith Gaming Corporation with the legal opinion of the City Legal Officer, Atty. Roderick S. Iquin, relative to the request for amendment of Resolution of No Objection (RONO) previously granted to the corporation;

WHEREAS, the Goldsmith Gaming Corporation respectfully seeks approval to expand its electronic gaming operations to include all PAGCOR-approved games, including traditional and electronic bingo, as part of its commitment to enhance service offerings to its clientele. Furthermore, the Corporation is requesting the transfer of its business operations from its current location at Unitop, Balzain to MEES Shopping Center, situated at the Luna corner Taft Street, Centro 02, Tuguegarao City;

WHEREAS, the proposed new location remains within the appropriate jurisdiction and is fully compliant with all applicable zoning and regulatory requirements;

WHEREAS, Resolution of No Objection (RONO) was the pre-requisite of Goldsmith Gaming Corporation in applying PAGCOR gaming license;

WHEREAS, that the following documentary requirements must be completed before issuing the Business Permit.;

- 3. Philippine Amusement and Gaming Corporation (PAGCOR) Gaming License.
- 4. Secretary Certificate Authorizing Ms. Janice A. Juan to represent Goldsmith Gaming Corporation
- 5. Articles of Incorporation
- 6. Lease of Contract of Biggame, Inc.
- 7. Site Floor Plan
- 8. Locational Clearance of Decision on Zoning (City Planning & Development Office)
- 9. Certificate of Occupancy, Survey Verification Plan (City Engineering Office)
- 10. BIR Certificate of Registration
- 11. Security and Exchange Commission Certificate
- 12. Mayor's Permit

WHEREAS, the management of Goldsmith Gaming Corporation shall prioritize employment of qualified residents from Tuguegarao City and that the gaming place be secured with outmost security;

WHEREAS, the failure of Goldsmith Gaming Corporation to follow the operational procedures of PAGCOR and/or its engagement in unscrupulous transactions shall be ground for the revocation and cancellation of its RONO;

WHEREAS, the operation of Goldsmith Gaming Corporation shall be governed and subjected to the provisions of local laws and ordinances of Tuguegarao City;

WHEREAS, by virtue of the Committee Report No. 106-2025 of the joint Committee on Games, Amusement and Entertainment and Committee on Rules, Laws and Ethics recommending the passage of a Resolution of No Objection (RONO) as a pre-requisite in the establishment and operation of approved PAGCOR Games at the Mees Shopping Center, Luna St. Corner Taft St,

Centro 02, Tuguegarao City was duly adopted during the 137<sup>th</sup> Regular Session of the Sangguniang Panlungsod held on May 20, 2025;

**NOW, THEREFORE, RESOLVE**, as it is hereby **RESOLVED**, to approve the request of Goldsmith Gaming Corporation for a Resolution of No Objection (RONO) to operate approved PAGCOR Games at the Mees Shopping Center, Luna St. Corner Taft St, Centro 02, Tuguegarao City.
