CITY RESOLUTION NO. 107-09-2025

RESOLUTION APPROVING THE EXTENSION OF THE MEMORANDUM OF UNDERSTANDING (MOU) BETWEEN THE TUGUEGARAO CITY GOVERNMENT AND DEPARTMENT OF HEALTH-CAGAYAN VALLEY CENTER FOR HEALTH DEVELOPMENT (DOH-CVCHD) RELATIVE TO THE HUMAN RESOURCES FOR HEALTH (HRH) DEPLOYMENT PROGRAM AND AUTHORIZING THE CITY MAYOR, HON. MAILA ROSARIO S. TING-QUE, TO SIGN FOR AND ON BEHALF OF THE TUGUEGARAO CITY GOVERNMENT THE SAID MOU

WHEREAS, Republic Act No. 7160, otherwise known as the Local Government Code of 1991, empowers local government units (LGUs) to establish partnerships with national government agencies to enhance the delivery of essential services, particularly in the health sector;

WHEREAS, the Department of Health-Cagayan Valley Center for Health Development (DOH-CVCHD) implements the Human Resources for Health (HRH) Deployment Program which provides essential health personnel to augment local healthcare services and strengthen the delivery of primary healthcare at the community level;

WHEREAS, the Tuguegarao City Government acknowledges the vital role of the HRH Deployment Program in ensuring accessible, efficient and effective health services for the city's constituents, particularly in underserved and geographically isolated areas;

WHEREAS, the Tuguegarao City Government and DOH-CVCHD seek to extend the existing Memorandum of Understanding (MOU) to continue their collaboration under the HRH Deployment Program, reinforcing efforts to improve healthcare service delivery in the city;

WHEREAS, the extension of the MOU will allow for the sustained deployment of health professionals, such as 11 nurses, 7 midwives and 1 Meditech to Tuguegarao City Health Office, in line with national health policies and local development goals;



WHEREAS, there is a need to authorize the City Mayor, Hon. Maila Rosario S. Ting-Que, to sign the extension of the MOU on behalf of the Tuguegarao City Government to formalize and facilitate the continued implementation of the program.


NOW, THEREFORE, RESOLVE, as it is hereby **RESOLVED**, to approve the extension of the Memorandum of Understanding (MOU) between the Tuguegarao City Government and Department of Health-Cagayan Valley Center for Health Development (DOH-CVCHD) relative to the Human Resources for Health (HRH) Deployment Program and to grant authority to the City Mayor, Hon. Maila Rosario S. Ting-Que, to sign for and on behalf of the Tuguegarao City Government the said MOU.

RESOLVED FURTHER, to furnish a copy of this Resolution to Department of Health-Cagayan Valley Center for Health Development (DOH-CVCHD), the City Health Office and other concerned offices for information and appropriate action.
