**COMMITTEE REPORT NO. 109-2025**

**SUBJECT:**

***“Indorsement of the City Mayor, Hon. Maila Rosario S. Ting-Que, on the draft Deed of Donation between the Tuguegarao City Government and the Bureau of Fire Protection (BFP) relative to the donation of a brand-new vehicle.”***

**ACTION TAKEN:**

The members of the committees met to discuss the subject matter with the presence of the resource persons.

**FINDINGS:**

- 1.) The Ninth City Council in its 101<sup>st</sup> Regular Session held on July 30, 2024 approved City Resolution No. 513-09-2024 titled *“Resolution Granting Authority To The City Mayor, Hon. Maila Rosario S. Ting-Que, To Utilize The Twenty Percent (20%) Share From The Fire Code Fees Collected For The Purchase Of A Brand-New Vehicle Amounting To P2,110,000.00 For Operations Purposes Of The Tuguegarao City Fire Station”*.
- 2.) The City Government desires to transfer to the BFP by way of donation the ownership of the brand-new vehicle described as follows:
  - a. Mitsubishi Triton Pick-up
  - b. ENGINE NUMBER: 00095145060
  - c. CHASSIS -NUMBER: MMBJLLB1OSH018559
  - d. COLOR: Jet Black Mica
- 3.) The funds for the purchase of the said vehicle was sourced out from the Trust Fund 20% LGU share from Fire Code Fee collections.
- 4.) The donated vehicle will be of great help to the BFP during disaster response, rescue, and transport of equipment and supplies in Tuguegarao City.

**RECOMMENDATION:**

**RESOLUTION APPROVING THE DEED OF DONATION BETWEEN THE TUGUEGARAO CITY GOVERNMENT AND THE BUREAU OF FIRE PROTECTION FOR THE DONATION OF A BRAND-NEW VEHICLE AND AUTHORIZING THE CITY MAYOR, HON. MAILA ROSARIO S. TING-QUE, TO SIGN FOR AND ON BEHALF OF THE TUGUEGARAO CITY GOVERNMENT THE SAID DEED OF DONATION**

**WHEREAS**, Section 455 of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that local chief executives shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance;

**WHEREAS**, the Ninth City Council approved City Resolution No. 513-09-2024 titled "*Resolution Granting Authority To The City Mayor, Hon. Maila Rosario S. Ting-Que, To Utilize The Twenty Percent (20%) Share From The Fire Code Fees Collected For The Purchase Of A Brand-New Vehicle Amounting To P2,110,000.00 For Operations Purposes Of The Tuguegarao City Fire Station*" during its 101<sup>st</sup> Regular Session held on July 30, 2024;

**WHEREAS**, the City Government desires to transfer to the Bureau of Fire Protection (BFP) by way of donation the ownership of the brand-new vehicle described as follows:

- a. Mitsubishi Triton Pick-up
- b. ENGINE NUMBER: 00095145060
- c. CHASSIS -NUMBER: MMBJLLB1OSH018559
- d. COLOR: Jet Black Mica

**WHEREAS**, the funds for the purchase of the said vehicle was sourced out from the Trust Fund 20% local government unit share from Fire Code Fee collections in accordance with City Resolution No. 513-09-2024;

**WHEREAS**, the City recognizes that the donated vehicle will be of great help to the BFP during disaster response, rescue, and transport of equipment and supplies in Tuguegarao City;

**WHEREAS**, the Ninth City Council during its 138<sup>th</sup> Regular Session held on May 27, 2025 deemed it necessary to approve the subject deed of donation and authorize the City Mayor to sign for and on behalf of the City Government.

**NOW, THEREFORE, RESOLVE**, as it is hereby **RESOLVED**, to approve the Deed of Donation between the Tuguegarao City Government and the Bureau of Fire Protection, and to authorize the City Mayor, Hon. Maila Rosario S. Ting-Que, to sign for and on behalf of the Tuguegarao City Government the Deed of Donation.

**RESOLVED FURTHER**, to furnish a copy of this resolution to the BFP for information and proper action.

## **DEED OF DONATION**

### **KNOWN BY ALL MEN BY THESE PRESENTS:**

This **DEED OF DONATION** is made and entered into this by and between:

**THE TUGUEGARAO CITY GOVERNMENT, CAGAYAN** a local government entity duly organized and existing under the laws of the Republic of the Philippines, represented in this act by its City Mayor, HON. MAILA ROSARIO S. TING-QUE, of legal age, Filipino, married with office address at Enrile Boulevard, Carig Sur, Tuguegarao City, hereinafter referred to as the "**DONOR**";

-and-

**THE BUREAU OF FIRE PROTECTION (BFP)**, a government agency established under Republic Act No. 6975, represented by **FIRE CHIEF SUPERINTENDENT JERRY C. LAMANERO, DSC**, Regional Director of BFP Regional Office No. 02, of legal age, Filipino, married, hereinafter referred to as the "**DONEE**";

Collectively, the Donor and Donee are herein referred to as **PARTIES**.

### **WITNESSETH:**

**WHEREAS**, the DONOR is the absolute and registered owner of the vehicle, which is more particularly described as follows:

- Mitsubishi Triton Pick-up
- ENGINE NUMBER: 00095145060
- CHASSIS -NUMBER: MMBJLLB1OSH018559
- COLOR: Jet Black Mica
- Fund Source: Trust Fund 20% LGU Share from Fire Code Fee Collection

**WHEREAS**, the DONOR desires to transfer by way of donation the ownership of the aforementioned vehicle unto the DONEE;

**WHEREAS**, the DONEE is willing to accept the donation of the vehicle from the DONOR, and has expressed its appreciation and gratitude for the generosity and kindness of the DONOR;

**NOW, THEREFORE**, for and in consideration of the mutual covenants and stipulations set forth below, the DONOR hereby voluntarily and freely transfers, conveys, and assigns by way of donation unto the DONEE, its successors and assigns, the above-described vehicle, subject to the following terms and conditions:

1. The DONOR hereby transfers ownership of the vehicle unto the DONEE without any consideration other than the desire to assist the Bureau of Fire Protection in its mandate to safeguard the community and provide fire safety services.
2. The DONEE hereby accepts the donation of the vehicle and undertakes to utilize the for the purpose for which it was intended--specifically, for the safety and emergency response services within the City of Tuguegarao, Cagayan
3. The DONEE shall shoulder the vehicle's maintenance expenses to be incurred without prejudice to the augmentation of the Donor subject to availability of funds.
4. The DONOR does not retain any interest in the ownership or control of the vehicle after the execution of this Deed of Donation. However, in exceptional circumstances, the DONOR may request the use of vehicle subject to the consent of the DONEE.
5. The acceptance of this donation by the DONEE is evidence of its agreement to all the terms and conditions herein stipulated.

6. This Deed of Donation shall be governed by the laws of the Republic of the Philippines, especially the provisions of the Civil Code of the Philippines pertaining to donations, and shall take effect upon its due execution by both parties.

7. Parties to the Deed hereby acknowledge that they have read and understood the provision herein and hereby express their conformity thereto and shall bind the successors, successors-in-interest, nominees, administrator and permitted assigns of each of the DONOR and DONEE.
