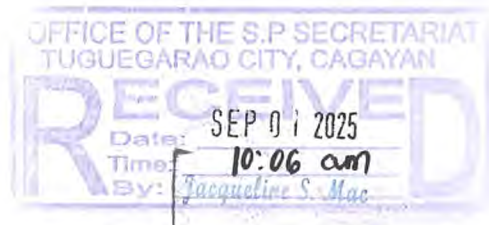

**“RESOLUTION APPROVING THE RENAMING AND ADOPTION OF THE  
IBANAG COUNCIL FOR CULTURE AND THE ARTS (ICCA) TO COUNCIL FOR  
CULTURE AND THE ARTS OF TUGUEGARAO CITY (CCATC)”**

**WHEREAS**, Article II, Section 17 of the 1987 Philippine Constitution declares that the state shall give priority, among others, to arts and culture in order to foster patriotism and nationalism, accelerate social progress, and promote total human liberation and development;

**WHEREAS**, the constitution further proclaims under Article XIV, Section 15 that the state shall conserve, promote, and popularize the nation’s historical and cultural heritage and resources as well as artistic creations;

**WHEREAS**, the Ibanag Council for Culture and the Arts (ICCA) passed Resolution No. 06-2025 outlining the renaming of said council to Council for Culture and the Arts of Tuguegarao City (CCATC);

**WHEREAS**, the renaming seeks to broaden the scope and representation of the council by aligning its identity more inclusively with the entire city’s cultural and artistic landscape, encompassing not only the ibanag heritage but also other cultural expressions present in Tuguegarao City.

**WHEREAS**, the proposed change is intended to enhance the council’s capacity to implement culturally relevant programs and policies, promote multi-sectoral engagement, strengthen institutional identity, and improve coordination with both local and national cultural bodies;

**NOW, THEREFORE, RESOLVED**, in view of the foregoing considerations, the Ibanag Council for Culture and the Arts acting as a collegial body, in quorum, TO APPROVE the Resolution Approving the renaming and adoption of the Local Culture and Arts Council from Ibanag Council for Culture and the Arts (ICCA) to Council for Culture and the Arts of Tuguegarao City (CCATC);
