This has reference to the order of Department of Human Settlements and Urban Development Regional Office No.2 dated April 18, 2024, the Suspension Order dated January 6, 2014 against City Peoples Memorial Park is hereby lifted. The Tuguegarao City Government is authorized to resume the selling of plots/gravesites within the said memorial park.

In this regard, considering the increase in land value overtime and additional development cost of the project, this office recommends to increase the charges for cemetery lots as prescribed under Section 5.C.01 (a) of City Ordinance No. 07-2011 or otherwise known as the Revenue Code of Tuguegarao City, from TWENTY-FIVE THOUSAND PESOS (₱25,000.00) to FIFTY THOUSAND PESOS (₱50,000.00) and additional fee of TEN THOUSAND PESOS (₱10,000.00) to be paid for the interment services.

We trust that this will help us increase our revenues.
