FOR THE PRESIDING OFFICER:

The Members of the Joint Committees met and deliberated on the Letter of the Production Manager of RBC Cable Master System, Mr. Rodel Ordillos, on the continued coverage of Regular and Special Sessions of the Sangguniang Panlungsod and to further request to be made retroactive to allow the collection of payments of services rendered since January 2025. The Joint Committees respectfully submit the herein Committee Report and has the honor to report to this August body in session the following actions taken, its findings and recommendations.

ACTIONS TAKEN:

The joint committees conducted a thorough and wholistic evaluation on the Letter of the Production Manager of RBC Cable Master System, Mr. Rodel Ordillos, on the continued coverage of Regular and Special Sessions of the Sangguniang Panlungsod and to further request to be made retroactive to allow the collection of payments of services rendered since January 2025.

Resource persons were present to assist the joint committees in the committee deliberation.

FINDINGS:

- 1. The referral pertaining to the "Letter of the Production Manager of RBC Cable Master System, Mr. Rodel Ordillos, on the continued coverage of Regular and Special Sessions of the Sangguniang Panlungsod and to further request to be made retroactive to allow the collection of payments of services rendered since January 2025" was endorsed to the Ninth City Council.
- 2. RBC Cable Master System has been a steadfast partner of the Tuguegarao City Government, committed to supporting its initiatives through effective and consistent information dissemination.
- 3. Their coverage and replay of the City Council's Regular and Special Sessions in their community channel have played a vital role in keeping citizens informed about the important resolutions and ordinances enacted by the Council.
- 4. This initiative for continued coverage of the Regular and Special Sessions will further strengthen public awareness of key legislative matters and ensure that constituents remain engaged and updated on developmental issues and concerns.
- 5. The request for retroactive payment from January 2025 will enable RBC Cable Master System to receive compensation for services already provided.
- 6. There is a need for the passage of a resolution approving the Memorandum of Agreement between and among the Office of the Vice Mayor, the Sangguniang Panlungsod and RBC Cable Master System on the continued coverage of RBC Cable Master System for the Regular and Special Sessions of the Sangguniang Panlungsod and authorizing the retroactive payment to allow compensation for services rendered beginning January 2025.

RECOMMENDATIONS:

The joint committees further recommend for the approval of retroactive payment to allow compensation for services rendered beginning January 2025.

MEMORANDUM OF AGREEMENT

KNOW ALL MEN NY THESE PRESENTS:

This Memorandum of Agreement entered into this _____ day of _____ 2025 by and between:

The OFFICE OF THE VICE MAYOR and the SANGGUNIANG PANLUNSOD with postal address of City hall, Tuguegarao City, Cagayan, represented herein by HON. BIENVENIDO C. DE GUZMAN II in his capacity as the Vice Mayor and Presiding Officer of the Sangguniang Panlungsod, hereinafter referred as the FIRST PARTY";

And

The **RBC CABLE MASTER SYSTEM** with postal address at #24 Luna Street, Tuguegarao City, Cagayan, represented by **MRS. EVELYN J. CINENSE** in her capacity as PRESIDENT hereinafter referred to as the **SECOND PARTY**";

WITNESSETH that:

WHEREAS, a weekly television program may be utilized as a means of disseminating information on the various activities, programs and projects of the office of the Vice Mayor and the Sangguniang Panlungsod of the City to keep the public in touch and abreast with the said programs and activities and to gather public support and promote the image of the City Government:

WHEREAS, the SECOND PARTY, is a popular television in the Province and has enough competence, efficiency and technical capacity to reach as far as the remotest Barangay of the City;

WHEREAS, the FIRST PARTY deems it necessary to continue the services of the SECOND PARTY in order to inform the public of its program, projects and activities;

NOW THEREFORE, in consideration of the foregoing premises and stipulation hereinafter set forth, the parties hereto agree and hereby agree as follows:

- That the Second Party shall devote ONE(1) hour a week for the airing or broadcasting of program dubbed as "THE REGULAR SESSION OF THE 9TH CITY COUNCIL" a television program which serves as an information dissemination endeavor of the Office of the Vice Mayor and Sangguniang Panlungsod which will telecast the regular and special sessions, of the Sangguniang Panlungsod, as well as the various programs, activities and projects of the aforementioned offices;
- That the Second Party shall undertake the coverage, editing and reproduction of every regular and special sessions, of the Sangguniang Panlungsod as well as the various programs, activities, plans and projects of the aforementioned offices,
- 3. That, in consideration of the above, the First Party shall pay the Second Party the amount of ₱40,000.00 per month as production cost (₱10,000 per hour × 4 times a month), for a total of ₱240,000.00 from January 2025 to June 2025.
- 4. That the First Party has the exclusive right of ownership over the media materialtherefore the sale distribution and or production of said material by the Second Party is hereby prohibited, unless upon written authority given by the First party;
- 5. That this contract shall commence January 2025 to June 2025.


