The Joint Committee met and deliberated on the referral:

**COMMITTEE REPORT NO. 125 -2025**

**SUBJECT:**

*“Letter of the Chief, Construction Section, Cagayan 3rd District Engineering Office of the DPWH, Mr. Victor L. Espanol, on the Guidelines on the Release of Funds for New Items of Appropriations Categorized as Conditional Implementation under FY 2025 General Appropriations Act for additional projects identified by the DPWH-Central Office which requires for City Resolution endorsing such projects.”*

**ACTION TAKEN:**

The members of the committees met to discuss the subject matter with the presence of the resource persons.

## **FINDINGS:**

- 1.) The Department of Public Works and Highways (DPWH) Cagayan Third District Engineering Office (CTDEO) wrote two separate letters dated May 19, 2028, and May 28, 2025 addressed to the City Vice Mayor, Hon. Bienvenido C. De Guzman II, the latter of which is the subject of this committee report, reiterating the provisions of the Fiscal Year 2025 General Appropriations Act (GAA) and the Department of Budget and Management (DBM) guidelines under DBM National Budget Circular for the release of funds from the 2025 GAA;
- 2.) The foregoing guidelines provide the specific requirements to facilitate the release of funds for new appropriations categorized as Conditional Implementation (CI) of several projects of the DPWH in Tuguegarao City;
- 3.) Among the requirements is a City Resolution from the Sangguniang Panlungsod (SP) of Tuguegarao endorsing such projects for implementation, and appropriate resolutions from the City Development Council (CDC).
- 4.) The deadline for submission of the said requirements by the DPWH is on June 30, 2025.
- 5.) The joint committee deemed it proper to refer the matter to the City Mayor to convene the City Development Council for the adoption of the programs, projects, and activities (PPAs) through a CDC resolution which can be later on endorsed to the SP.

## **RECOMMENDATION:**

After discussing the subject matter, this Joint Committee respectfully urges the DPWH CTDEO to submit a letter addressed to the City Mayor, Hon. Maila Rosario S. Ting-Que, requesting for the City Development Council (CDC) to convene and tackle the said subject matter. The joint committee further recommends the following:

1. For the City Engineering Office to coordinate with the DPWH CTDEO regarding the guidelines for City projects.
2. For DPWH CTDEO to align their PPAs with the Annual Investment Program (AIP) and the Local Development Plan (LDP) of the City so that there will be no duplication of projects to be implemented or funded.

Let a copy of this Committee Report be forwarded to the DPWH CTDEO and the Office of the City Mayor for information and appropriate action.
