CITY RESOLUTION NO. 127-10-2025

**RESOLUTION APPROVING THE REQUEST OF VARGAS SPORTS COLISEUM TO
HOLD SPECIAL COCKFIGHTS ON OCTOBER 31, 2025**

WHEREAS, the City Mayor, Hon. Maila Rosario S. Ting-Que, indorsed to the Tenth City Council the request of Mr. John Vargas Esquillo relative to the holding of special cockfights at the Vargas Sports Coliseum for information and appropriate action;

WHEREAS, Section 10(D) of City Ordinance No. 32-08-2019 states that the City Mayor may issue permits for special cockfights, cock or stag derbies including cockfights via satellite participated in by cockers and breeders through invitations upon application duly approved by the Sangguniang Panlungsod through resolution of 30-working days before the scheduled playdate and that the authority to hold special cockfights or derbies and Barangay sponsored cockfights should always be covered by a Resolution of the Sangguniang Panlungsod and the Mayor's Permit;

WHEREAS, the holding of cockfights must adhere to strict compliance of City Ordinance No. 32-08-2019 and failure of the Vargas Sports Coliseum to secure special permit from the Office of the City Mayor in the conduct of special cockfights shall cause the recall of the resolution approving the conduct of such cockfights;

WHEREAS, as manifested by the resource person, the requested special cockfighting is a derby in nature with the purpose of providing a total fixed amount of P10,000.00 cash support to Mr. Joemar Baligod, 40 years old patient from Cataggaman Viejo diagnosed with leukemia and undergone chemotherapy;

WHEREAS, after the discussion of the said request, the committee approved the October 31, 2025 scheduled playdate only;

WHEREAS, by virtue of Committee Report No. 26-10-2025, duly adopted during the 11th Regular Session of the Tenth City Council held on September 12, 2025, the Committee on Games, Entertainment and Amusement recommended the approval for the conduct of special cockfight on October 31, 2025 only;




RESOLVED FURTHER, to furnish a copy of this Resolution to Vargas Sports Coliseum for information.
