RESOLUTION URGING THE CITY MAYOR TO UTILIZE THE FINANCIAL ASSISTANCE AMOUNTING TO TEN MILLION PESOS (P10,000,000.00) DONATED BY THE OFFICE OF THE PRESIDENT, REPRESENTED BY UNDERSECRETARY AL-AZREE J. MOHAMMADSALI PROVIDED UNDER CITY RESOLUTION NO. 622-09-2024

WHEREAS, Section 16 of Republic Act. No. 7160, otherwise known as the Local Government Code of 1991, provides that “Every Local Government Unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate or incidental for its efficient governance, and those which are essential to the promotion of the general welfare”;

WHEREAS, Section 455 paragraph (b) (2) of the Local Government Code provides that the Local Chief Executive shall enforce all laws and ordinances relative to the governance of the city and in the



exercise of the appropriate corporate powers provided for under Section 22 of the same, implement all approved policies, programs, projects, services and activities of the city;

WHEREAS, Section 2(p) on the Declaration of Policy of Republic Act 10121, also known as the “Philippine Disaster Risk Reduction and Management Act of 2010,” states that it shall be the policy of the State to provide maximum care, assistance and services to individuals and families affected by disaster, implement emergency rehabilitation projects to lessen the impact of disaster and facilitate resumption of normal social and economic activities;

WHEREAS, the Province of Cagayan has been greatly affected by the heavy rainfall, strong winds and flooding brought about by the five (5) successful tropical storms and typhoons Kristine, Leon, Marce, Nika and Ofel in October-November, 2024;

WHEREAS, among the Local Government Units in Cagayan which has been affected greatly by the said tropical storms is Tuguegarao City;

WHEREAS, the Office of the President donated to the Tuguegarao City Government the total amount of Ten Million Pesos (P10,000,000.00), from the Socio-Civic Projects Funds (SCPF), by virtue of OP Office Order No. 02 dated 29 December 2016 and the approved Memorandum for the Executive Secretary dated 14 November 2024;

WHEREAS, the City Mayor, Hon. Maila Rosario S. Ting-Que, has received, for and on behalf of the City Government the amount of Ten Million Pesos (P10,000,000.00), pursuant to the authority granted to her by the Ninth City Council, by virtue of City Resolution No. 622-09-2024, titled *Resolution Approving the Deed of Donation Between the Tuguegarao City Government and the Office of the President, Represented by Undersecretary Al-Azree J. Mohammadsali, Relative to the Donation of Ten Million Pesos (P10,000,000.00) as Financial Assistance and Authorizing the City Mayor, Hon. Maila Rosario S. Ting-Que, to Sign for and on Behalf of the Tuguegarao City Government the said Deed of Donation*;

WHEREAS, among the conditions stated in the subject Deed of Donation is the utilization of the Ten Million Pesos (Php10,000,000.00) within one (1) year from its receipt;

WHEREAS, several households/families in the city were severely affected by the heavy rainfall, strong winds and flooding brought about by the five (5) successive tropical storms and typhoons, Kristine, Leon, Marce, Nika and Ofel hence, the city government must extend the required assistance to the aforementioned household/families;

WHEREAS, the Ninth City Council urge the City Mayor, Hon. Maila Rosario S. Ting-Que, to release the financial assistance amounting to Ten Million Pesos (Php10,000,000.00) donated by the Office of the President, Represented by Undersecretary AL-AZREE J. MOHAMMADSALI provided under City Resolution No. 622-09-2024.



