CITY RESOLUTION NO. 129-10-2026

**RESOLUTION APPROVING THE REQUEST OF DUPAYA RECREATION CENTER
TO CONDUCT HACKFIGHTS (ULUTAN) ON JUNE 1, 8, 15, 22 AND 29, 2026**

WHEREAS, The City Mayor, Hon. Maila Rosario S. Ting-Que, indorsed to the Tenth City Council the request of Ms. Elizabeth G. Dupaya seeking authority to conduct hackfights (Ulután) on various dates for the Month of June 2026;

WHEREAS, Section 10(D) of City Ordinance No. 32-08-2019 states that the City Mayor may issue permits for special cockfights, cock or stag derbies including cockfights via satellite participated in by cockers and breeders through invitations upon application duly approved by the Sangguniang Panlungsod through resolution of 30-working days before the scheduled playdate and that the authority to hold special cockfights or derbies and Barangay sponsored cockfights should always be covered by a Resolution of the Sangguniang Panlungsod and the Mayor's Permit;

WHEREAS, Section 1(a) of Executive Order No. 9, Series of 2022 issued on December 28, 2022 from the Office of the President, provides that "*on the Continued Suspension of E-Sabong Operations. All E-Sabong operations, including all auxiliary E-Sabong operations, shall continue to be suspended nationwide. Consistent with the Regulatory Framework for E-Sabong issued by the PAGCOR, and relevant laws, rules and regulations, shall include Live-streaming or broadcasting of live cockfights outside cockpits or cockfighting arenas, or premises where cockfights are being held;*"

WHEREAS, As manifested by the representative of Dupaya Recreation Center, the requested hackfights (Ulután) are intended to provide cash support to the beneficiaries for the following dates:

- June 1, 2026 – Ms. Tesie Baxa, 62 years old from Atulayan Norte, diagnosed with Hypertension/Rheumatoid Arthritis
- June 8, 2026 – Ms. Nora Guillermo from Atulayan Norte, stroke patient, paralyzed
- June 15, 2026 – Ms. Berlinda Corsino from Peñablanca, diagnosed with Hypertension
- June 22, 2026 – Ms. Irene Nora, 52 years old from Atulayan, diagnosed with Diabetes

e. June 29, 2026 – Ms. Irene Nora, 52 years old from Atulayan, diagnosed with Diabetes

WHEREAS, Aligned and consistent with the previous approval and the basis for providing cash support to the above beneficiaries, if the operation incurs a loss or earns income up to P20,000.00, the amount of P2,000.00 shall be extended as assistance and for every additional income bracket of P10,000.00 beyond P20,000.00, an additional P1,000.00 shall be given;

WHEREAS, After the discussion of the said request, the committee approved the scheduled playdates on June 1, 8, 15, 22 and 29, 2026;

WHEREAS, Committee Report No. 64-10-2026 of the Committee on Games, Entertainment and Amusement which recommends for the approval for the conduct of hackfights (Ulután) on June 1, 8, 15, 22 and 29, 2026 was duly adopted during the 34th Regular Session of the Sangguniang Panlungsod held on March 03, 2026;

WHEREAS, The approval is further conditioned upon operating only until 12:00 Midnight, and any failure to secure the required Special Permit from the Office of the City Mayor for the conduct of said special cockfights shall constitute sufficient ground for the recall of the resolution approving the same;

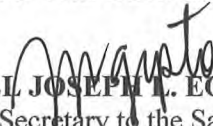
