**ACTIONS TAKEN:**


1. The committee conducted a thorough and wholistic evaluation of the subject matter on April 15, 2024.

**FINDINGS AND RECOMMENDATIONS:**


After a thorough discussion on the subject matter, the committee hereby recommends the following, to wit:

1. That Barangay Leonarda shall come up with a Resolution Adopting and Strongly Implementing City Ordinance No. 13-2002 of the City of Tuguegarao on the Prohibition of the use of Streets, Alleys, Road Right of Ways, and Open Public Spaces for Drinking Liquor and other Intoxicating Beverages instead of an Ordinance.
2. That Barangay Leonarda may include in their resolution a provision regarding extensive information-dissemination campaign program on how they intend the ordinance to be disseminated in their barangay.
