The Committee of the Whole deliberated on the following:

COMMITTEE REPORT NO. 130-2025

SUBJECT:

Indorsement of the City Mayor, Hon. Maila Rosario S. Ting-Que, on the following City Development Council Resolutions:

- CDC Resolution No. 08-2025 *Resolution Adopting and Endorsing to the August Sangguniang Panlungsod the herein Supplemental Local Development Investment Program (SLDIP) No. IX, CY 2023-2028 for appropriate action; and*
- CDC Resolution No. 09-2025 *Resolution Endorsing to the Sangguniang Panlungsod the herein Supplemental Annual Investment Program (SAIP) No. 1 CY 2025 for appropriate action*

ACTIONS TAKEN:

The Committee of the Whole, with the presence of the members of the Local Finance Committee, Project In-Charge and Program Managers, met to review the subject CDC Resolutions.

Ms. Chona Sedano, CPDO, presented the various priority programs, projects and activities (PPAs) contained therein and its funding requirements.

FINDINGS:

On CDC Resolution No. 08-2025:

1. There are new priority programs, projects and activities (PPAs) that are necessary and indispensable for the promotion of public welfare.
2. There is a need to integrate these new PPAs in the approved Local Development Investment Program (LDIP) as supplements thereof for the improvement of facilities and effectiveness of services of the Tuguegarao City Government.

Ms. Sedano, mentioned, among others, a typographical error in the endorsed copy of the SLDIP specifically on the locations for the installation of LED Walls, which are intended to be installed in five (5) locations as discussed in the CDC meeting, and to delete therein the two (2) other locations: Tug. City Commercial Center and Multi-Purpose Building at Carig Sur. Anent this, Ms. Sedano was requested to submit the minutes of said meeting upon the request of Hon. Dayag, and the corrected SLDIP as certified and signed by the Mayor.

On CDC Resolution No. 09-2025:

1. The Supplemental Annual Investment Program (SAIP) embodies various PPAs and other items of expenditure that are necessary for public service, general welfare and public convenience, including upgrading, repair, and maintenance of public facilities and equipment and implementation of environmental management projects.
2. The Personal Services (PS) of the Local Government Unit of Tuguegarao City is a major component of the Supplemental Annual Investment Program (SAIP) by virtue of Executive Order No. 64, Section 04 dated August 2, 2024 which provides guidelines updating the salary of Civilian Government Personnel including the Salary Adjustments of Local Government Units.
3. There are various PPAs and other items of expenditure that need to be integrated into the SAIP as supplements thereof which shall form part of the Supplemental Budget No. 01 CY 2025.
4. An increase in the Personal Services (PS) component because there are additional employees who are entitled to receive their terminal pay.
5. The corresponding programs of work for the various PPAs were submitted.

The committee required the submission of more detailed programs of work.

Further, the committee duly noted Ms. Sedano's statement that the procurement of inert soil will be prioritized during the preparation of the ensuing Annual Investment Program (AIP), and it was suggested by the committee that the procurement of an equipment for inert soil will be undertaken by the administration as this will result to more savings on the part of the city government.

RECOMMENDATION:

After a thorough discussion and finding the subject CDC Resolutions to be in order, with merit and beneficial to the Tuguegarao City Government and its constituents, the Committee of Whole favorably recommends the approval of the concomitant City Resolutions Adopting and Approving CDC Resolution No. 08-2025 and CDC Resolution No. 09-2025.
