SUBJECT:

Indorsement of the City Mayor, Hon. Maila Rosario S. Ting-Que, on the draft Memorandum of Agreement between and among the Tuguegarao City Government and various Regional Government Agencies relative to the maintenance of cleanliness of the Regional Government Center (RGC).

FOR THE PRESIDING OFFICER:

The Members of the Committee met and deliberated on the Indorsement of the City Mayor, Hon. Maila Rosario S. Ting-Que, on the draft Memorandum of Agreement between and among the Tuguegarao City Government and various Regional Government Agencies relative to the maintenance of cleanliness of the Regional Government Center (RGC). The Committee respectfully submits the herein Committee Report and has the honor to report to this August body in session the following actions taken, its findings and recommendations.

ACTIONS TAKEN:

The committee conducted a thorough and wholistic evaluation on the Indorsement of the City Mayor, Hon. Maila Rosario S. Ting-Que, on the draft Memorandum of Agreement between and among the Tuguegarao City Government and various Regional Government Agencies relative to the maintenance of cleanliness of the Regional Government Center (RGC) on June 13, 2025.

Resource persons were present to assist the committee in the committee deliberation. A representative from DENR-RO2, Atty. Ellen Javier presented and discussed the provision of the Memorandum of Agreement.

FINDINGS:

1. The Regional Government Center (RGC) which is strategically located at the northern part of Tuguegarao City is where the Regional Offices of all the National Government Agencies (NGAs) and Commissions, including Government-Owned and Controlled Corporations (GOCCs) are situated.
2. The RGC must be environment-friendly and maintained clean by all the National Government Agencies (NGAs) and Commissions including Government-Owned and Controlled Corporations (GOCCs) situated therein.

3. It is hereby declared the policy of the State to adopt a systematic, comprehensive and ecological solid waste management program which shall ensure the protection of the public health and environment pursuant to Republic Act No. 9003 (RA No. 9003), otherwise known as the "Ecological Solid Waste Management Act of 2000".
4. By virtue of Executive Order No. 192 (E.O No. 192), the Department of Environment and Natural Resources (DENR-RO2) is the primary government agency responsible for conservation, management, development and proper use of the country's environment and natural resources.
5. The parties recognized the importance of collaboration and partnership in order to achieve the objectives of the project, and have agreed to support and work together for the clean and green revolution activity, consistent with the objectives and requirements of their respective mandates and programs.
6. FCF Minerals Corporation donated waste bins to DENR Region 02 for distribution among National Government Agencies (NGAs), Commissions, and Government-Owned and Controlled Corporations (GOCCs) within the RGC.
7. Twenty-nine (29) sets of three waste bins, each consisting of nabubulok, di-nabubulok and nareresiklo, shall be installed strategically within the RGC.
8. The Local Government Unit (LGU) of Tuguegarao City shall collect the wastes from the twenty-nine (29) waste bins on the following schedule: Biodegradable shall be collected on Mondays, Wednesdays, and Fridays. Non-Biodegradable and Recyclable shall be collected on Tuesdays, Thursdays and Saturdays.
9. Ecological Solid Waste Management (ESWM) Committee (ESWM Committee) shall be created which shall be composed of two (2) focal persons, one (1) from CDD-DENR Regional Office 02 and one (1) from EMB Regional Office-02.
10. Hon. Jude T. Bayona suggested that categorized list differentiating biodegradable and non-biodegradable materials be labeled in the trash bins to enhance people's awareness on waste segregation.

RECOMMENDATIONS:

Finding the subject matter to be in order, with merit and beneficial to the Tuguegarao City Government and Regional Government Center, the committee favorably recommends for the passage of a Resolution Approving the Memorandum of Agreement between the Tuguegarao City Government and Department of Environment Natural Resources DENR-RO2 relative to the maintenance of cleanliness of the Regional Government Center (RGC).

The committee further recommends for the passage of a Resolution Granting Authority to the City Mayor, Hon. Maila Rosario S. Ting-Que, to sign for and on behalf of the Tuguegarao City Government the said MOA.



CITY GOVERNMENT THE SAID MOA**

WHEREAS, the Regional Government Center (RGC) which is strategically located at the northern part of Tuguegarao City is where the Regional Offices of all the National Government Agencies (NGAs) and Commissions, including Government-Owned and Controlled Corporations (GOCCs) are situated.

WHEREAS, there is a need for the passage of a resolution granting authority to the City Mayor, Hon. Maila Rosario S. Ting-Que, to sign for and on behalf of the Tuguegarao City Government the said MOA;

WHEREAS, upon the evaluation of the subject referred, the Committee on Rules, Laws and Ethics recommends for the Adoption and Approval of the Memorandum of Agreement and Granting of Authority to the City Mayor to sign for and on behalf of the Tuguegarao City Government the said MOA.

NOW, THEREFORE RESOLVED, as it is hereby **RESOLVED**, to approve the Memorandum of Agreement between the Tuguegarao City Government and Department of Environment and Natural Resources (DENR) relative to the maintenance of cleanliness of the Regional Government Center (RGC) and to grant authority to the City Mayor, Hon. Maila Rosario S. Ting-Que, to sign for and on behalf of the Tuguegarao City Government the said MOA.
