**SUBJECT: LETTER REQUEST OF MR. MAGNO Y. LIM FOR THE RECONSIDERATION OF CITY RESOLUTION NO. 440-09-2023 TITLED “RESOLUTION DENYING THE APPLICATION OF LEGISLATIVE FRANCHISE OF MAGNO Y. LIM TRANSPORT TERMINAL FOR THE ESTABLISHMENT OF TRANSPORT TERMINAL IN TUGUEGARAO CITY”**

**FOR THE PRESIDING OFFICER:**

The Committee of the Whole met and deliberated on the above subject matter pertaining to the Letter For Reconsideration of Mr. Magno Y. Lim to City Resolution No. 440-09-2023 denying the application of Magno Y. Lim Transport Terminal for legislative franchise to operate public transport terminal in Tuguegarao City particularly located at Diversion Road, San Gabriel, Tuguegarao City

**FINDINGS:**

On the Letter dated September 22, 2023 of Mr. Magno Y. Lim asking for the reconsideration of City Resolution No. 440-09-2023 denying his application for legislative franchise to operate public transport in Tuguegarao City. In his Letter, Mr. Lim stated that he intends to submit and comply with all the documentary as well as physical requirements for the establishment of public transport terminal.

However, upon inquiry from Mr. Lim's representative and as stated in his Letter, the area applied for his terminal is located at Diversion Road, San Gabriel, Tuguegarao City. The area is located within the Three Hundred (300) meter prohibited area designated/considered as choke point by Tuguegarao City Ordinance No. 48-08-2019, otherwise known as "An Ordinance Regulating the Establishment, Operation and Maintenance of Public/Private Transport Terminals within the Territorial Jurisdiction of Tuguegarao City, Cagayan and Providing Penalties Thereof".


**RECOMMENDATION:**

After thorough discussions, the Committee of the Whole recommends to deny Letter For Reconsideration of Mr. Magno Y. Lim to City Resolution No. 440-09-2023 which denied the application of Magno Y. Lim Transport Terminal for legislative franchise to operate public transport terminal in Tuguegarao City particularly located at Diversion Road, San Gabriel, Tuguegarao City.

The Committee further recommends to furnish copy of this Committee of the Whole Report to Mr. Magno Y. Lim for his information.


