ACTIONS TAKEN:

The Joint committees conducted a thorough and wholistic evaluation on the Indorsement of the City Mayor, Hon. Maila Rosario S. Ting-Que, on the letter of the City Treasurer, Mr. Buenaventura F. Lagundi, requesting the opening of a separate Land Bank of the Philippines account purposely for the implementation of the Memorandum of Agreement on Link.BizPortal which was authorized by the Sangguniang Panlungsod by virtue of City Resolution No. 594-09-2024 on June 13, 2025.

Resource persons were present to assist the joint committees in the committee deliberation.

FINDINGS:

- 1. The Ninth City Council in its 113th Regular Session Held on September 29, 2024, approved the City Resolution No 596-94-2024 "Resolution Approving the Payroll Servicing Agreement Between the Tuguegarao City Government and the Landbank of the Philippines (LBP) Relative to the Landbank Link.BIzPortal and Granting Authority to the City Mayor, HON. Maila Rosario S. Ting-Que, to Sign for and on Behalf of the Tuguegarao City Government the Said Agreement".
- 2. The City Treasurer in his letter dated May 27, 2025 requested for the opening of a separate Land Bank of the Philippines account purposely for the implementation of the Memorandum of Agreement on Link.BizPortal which was authorized by the Sangguniang Panlungsod by virtue of City Resolution No. 594-09-2024.
- 3. The Link, BizPortal is the system of the Landbank of the Philippines for the adoption of general collections.
- 4. The City Government of Tuguegarao does not have a depository account for general fund in the Landbank of the Philippines.

RECOMMENDATIONS:

Finding the subject matter to be in order, with merit and beneficial to the Tuguegarao City Government and its constituents, the joint committee favorably recommend for the approval on the request of City Treasurer that separate account with Landbank of the Philippines purposely for the implementation of the Memorandum of Agreement on Link.BizPortal which was authorized by the Sangguniang Panlungsod by virtue of City Resolution No. 594-09-2024 on June 13, 2025.
