The committee met and deliberated on the referral:

SUBJECT:

Indorsement of the City Mayor, Hon. Maila Rosario S. Ting-Que, requesting for an authority to represent, enter and sign for and on behalf of the City Local Government Unit of Tuguegarao the renewal of the draft Memorandum of Agreement with Cagayan Valley Medical Center, represented by Dr. Glenn Matthew G. Baggao, for the establishment of a Clinical Laboratory/Drug Testing and Radiology Consortium.

FINDINGS:

1. Hon. Maila Rosario S. Ting-Que indorsed to the Ninth City Council the request for an authority to represent, enter and sign for and on behalf of the City Local Government Unit of Tuguegarao the draft Memorandum of Agreement with Cagayan Valley Medical Center, represented by Dr. Glenn Mathew G. Baggao, for the establishment of a Clinical Laboratory/Drug Testing and Radiology Consortium
2. Tuguegarao City People's General Hospital (TCPGH) and Cagayan Valley Medical Center (CVMC) are both licensed Hospital by the Department of Health-Center for Health Development, Region II and Philippine Health Insurance Corporation.
3. In various instances, TCPGH may not be able to provide usual laboratory and Radiology services to its patient, hence there is a need to enter in a Memorandum of Agreement with CVMC that has an existing Tertiary Clinical Laboratory, Drug Testing and Diagnostic Radiology Services.

4. In order to make the partnership legally binding between the parties, there is a need for the here-stated MOA to be entered into by CVMC and the Tuguegarao City Government.

RECOMMENDATION:

Finding the terms and conditions of the Memorandum of Agreement (MOA) to be in order and beneficial to the constituents of Tuguegarao City, the committee recommends the approval of the the renewal of the Memorandum of Agreement with Cagayan Valley Medical Center, represented by Dr. Glenn Matthew G. Baggao and Tuguegarao City Government for the establishment of a Clinical Laboratory/Drug Testing and Radiology Consortium and authorizing the City Mayor Hon. Maila Rosario S. Ting-Que, to sign for and on behalf of the Tuguegarao City Government the said MOA.

DRAFT RESOLUTION APPROVING THE RENEWAL OF MEMORANDUM OF AGREEMENT (MOA) WITH CAGAYAN VALLEY MEDICAL CENTER (CVMC), REPRESENTED BY DR. GLENN MATHEW G. BAGGAO, FOR THE ESTABLISHMENT OF A CLINICAL LABORATORY/DRUG TESTING AND RADIOLOGY CONSORTIUM AND GRANTING AUTHORITY TO THE CITY MAYOR, HON. MAILA ROSARIO S. TING-QUE, TO SIGN FOR AND ON BEHALF OF THE TUGUEGARAO CITY GOVERNMENT THE SAID MEMORANDUM OF AGREEMENT



WHEREAS, Section 22(c) of Republic Act No. 7160, otherwise known as the Local Government Code, grants the power to the Local Chief Executive to enter into contracts on behalf of the local government unit with prior authorization by the Sangguniang Panlungsod;

WHEREAS, the City Mayor, Hon. Maila Rosario S. Ting-Que, requested for an authority to represent, enter and sign for and on behalf of the City Local Government Unit of Tuguegarao the draft Memorandum of Agreement with Cagayan Valley Medical Center, represented by Dr. Glenn Mathew G. Baggao, for the establishment of a Clinical Laboratory/Drug Testing and Radiology Consortium;

WHEREAS, the Tuguegarao City Peoples General Hospital (TCPGH) and Cagayan Valley Medical Center (CVMC) are both licensed Hospital by the Department of Health-Center for Health Development, Region II and by the Philippine Health Insurance Corporation (PHIC);

WHEREAS, the CVMC has an existing Tertiary Clinical Laboratory, Drug Testing and Diagnostic Radiology Service;

WHEREAS, the TCPGH in various instances may not be able to provide usual laboratory and Radiology services to its patients;

WHEREAS, the CVMC may have Laboratory testing and Radiology services not available in TCPGH;

WHEREAS, the TCPGH and CVMC agree to establish a Clinical Laboratory/Drug Testing Consortium;

NOW, THEREFORE, RESOLVE, as it is hereby **RESOLVED**, to approve the renewal of the Memorandum of Agreement (MOA) with Cagayan Valley Medical Center (CVMC), represented by Dr. Glenn Mathew G. Baggao, for the establishment of a clinical laboratory/drug testing and radiology consortium and granting authority to the City Mayor, Hon. Maila Rosario S. Ting-Que, to sign for and on behalf of the Tuguegarao City Government the said MOA.
