FINDINGS:

- 1. Hon. Maila Rosario S. Ting-Que, indorsed to the Ninth City Council the request for an authority to represent, enter and sign for and on behalf of the City Local Government Unit of Tuguegarao the draft Memorandum of Agreement with Cagayan Valley Medical Center relative to the re. Implementation of Community-Based Drug Rehabilitation.
- 2. Department Memorandum No. 2021-0512 otherwise known as the Intern Guidelines for the Certification of Community Bases Drug Rehabilitation Program, mandates Local Government Units (LGUs), as the implementers to Community-Based Drug Rehabilitation Program (CBDRP), established and operated their local programs by implementing different models depending on available resources in the community.

- 3. The Local Government Unit of Tuguegarao City desires to engage the medical and clinical services of the Cagayan Valley Medical Center represented by its Medical Center Chief of Hospital II, Glenn Matthew Baggao to standardize the implementation of the Community-Based Drug Rehabilitation Program (CBDRP) and assure quality services provided to Persons Who Use Drugs (PWUDs) in the community.
- 4. In order to make the partnership legally binding between the parties, there is a need for the here-stated MOA to be entered into by CVMC and the Tuguegarao City Government.
