CITY RESOLUTION NO. 145-09-2025

RESOLUTION APPROVING THE REQUEST OF DUPAYA RECREATION CENTER, INC. TO HOLD HACKFIGHTS ON APRIL 09, 14, 16, 21, 23, 28 & 30, 2025 ONLY AND DENYING THE REQUEST OF SCHEDULED PLAYDATES ON APRIL 02 & 07, 2025

WHEREAS, the City Mayor, Hon. Maila Rosario S. Ting-Que, indorsed to the Ninth City Council the request of the Dupaya Recreation Center, Inc., Ms. Elizabeth G. Dupaya, relative to the holding of hackfights on various dates for the month of April 2025;

WHEREAS, the said indorsement was referred to the Committee on Games, Amusement and Entertainment and Committee on Rules, Laws and Ethics for review and appropriate action;

WHEREAS, pursuant to Section 10(d) of the City Ordinance No. 32-08-2019, otherwise known as the "Tuguegarao City Revised Cockfighting Ordinance of 2005," states that the City Mayor may issue permits for special cockfights, cock or stag derbies including cockfights via satellite participated in by cockers and breeders through invitations upon application duly approved by the Sangguniang Panlungsod through a resolution 30-working days before the scheduled playdate and it is further states that the authority to hold special cockfights or derbies and Barangay sponsored cockfights should always be covered by a Resolution of the Sangguniang Panlungsod and the Mayor's Permit;

WHEREAS, the holding of hackfights must adhere to the strict compliance of City Ordinance No. 32-08-2019 and the failure of the Dupaya Recreation Center, Inc. to secure special permit from the Office of the City Mayor in the conduct of special cockfights shall be meted out with the corresponding sanctions provided therein;

WHEREAS, after the discussion of the said request, the joint committees approved the scheduled play dates on April 09, 14, 16, 21, 23, 28 and 30, 2025 only but did not approve the requested scheduled play dates on April 02 & 07, 2025, on the ground that it is in violation of Section 10(b) of the City Ordinance No. 32-08-2019

WHEREAS, after a thorough deliberation on the request of Dupaya Recreation Center, Inc., and finding the same to be beneficial for the people of Tuguegarao City, the Committee on Games, Entertainment and Amusement and Committee on Rules, Laws and Ethics recommend the approval of the conduct of special derbies on April 09, 14, 16, 21, 23, 28 and 30, 2025, as stated in the Committee Report No. 666-2025, which was adopted during the 127th Regular Session of the Sangguniang Panlungsod held on February 25, 2025.

NOW, THEFORE, RESOLVE, as it is hereby, **RESOLVED,** to approve the request of Dupaya Recreation Center, Inc. to hold hackfights on April 09, 14, 16, 21, 23, 28 and 30, 2025 only and denying the request for scheduled playdates on April 02 & 07, 2025.

RESOLVED FURTHER, to furnish a copy of this resolution to Dupaya Recreation Center for information.
