WHEREAS, Republic Act (RA) No. 6847 is an act creating and establishing the Philippine Sports Commission, defining its powers, functions and responsibilities, appropriating funds therefor, and for other purposes;

WHEREAS, Section 2 of Republic Act (RA) No. 6847 states that the policy of the State is to promote physical education, encourage and sustain the development of sports in the country to foster physical fitness, self-discipline, teamwork and excellence for the development of a healthy and alert citizenry through a unified national sports promotion and development program, and that the establishment and creation of a single, unified and integrated national sports policy-making body shall further this objective;

WHEREAS, Republic Act (RA) No. 6847 states that national sports associations are organized for their respective sports in the Philippines and/or affiliated with their respective international federations which are recognized by the International Olympic Committee;

WHEREAS, shitokai is a technical characteristic which includes not only thrusting and kicking but also techniques such as throwing and reverse techniques, giving it the appearance of a comprehensive martial arts;

WHEREAS, Brunei launched the Shitokai Open Karate Championship 2023 as part of the exciting Brunei December Festival wherein both local and international athletes (any style/club) were invited providing a platform to showcase the skills and to bring about all karate talents to the region while experiencing the cultural richness of Brunei;

WHEREAS, there were four (4) countries who participated in the said event, namely: Malaysia, India, Philippines and Brunei and 200 participants from these countries competed with each other.

WHEREAS, the Tuguegarao City Government recognizes the efforts of its citizens and institutions towards excellence and distinction that bring honor to the City, worthy of admiration and merit;

WHEREAS, LOUIEMAHR JHOENG A. PINEDA, 10 years of age, a resident of Barangay Caggay and the son of MS. KRISTINA A. PINEDA, won a *Gold Medal* under 10-11 years old category in the Shitokai Brunei Open Karate Championship 2023 held at Stadium Hassanal Bolkiah, Brunei on December 1-3, 2023;
