SUBJECT:

Draft Resolution Creating the Cultural Inventory of the Tuguegarao City Government and endorsing the same to the National Commission for Culture and the Arts (NCCA) to form part of the Philippine Registry of Cultural Property (PRECUP)

FINDINGS:

1. This Resolution is pursuant to Sections 2 and 14 (b) and (c) of RA10066, otherwise known as the “National Cultural Heritage Act of 2009” mandates the protection, preservation, conservation, and promotion of the nation’s cultural heritage, its properties and histories, and the ethnicity of local communities.
2. In compliance thereto, Joint Memorandum Circular No. 2018-01 of the NCCA and the Department of the Interior and Local Government (DILG) dated October 9, 2018 is issued enjoining all LGUs to establish and maintain a local inventory of cultural property which shall form part of the PRECUP as supplemented by Joint Memorandum Circular No. 2021-001 dated May 7, 2023 stipulating the “Amended Guidelines on the Standardized Submission of Local Cultural Inventory under the PRECUP for the issuance of certificate of compliance to local government units”.
3. included in the checklist in submitting a local cultural inventory is a Sangguniang Panlungsod resolution creating the cultural inventory of the LGU and endorsing the same to the NCCA to form part of the PRECUP

4. The City Tourism Office, recommended an inventory of the following cultural properties of the city to wit:

1. **Cagayan Museum** (*Tangible Immovable*)
2. **Hammer** (*Tangible movable*)
3. **Horno** (*Tangible Immovable*)
4. **Mallattu ta Umo** (*Intangible*)
5. **Mappanday** (*Intangible*)
6. **Pinacanauan** (*Tangible Immovable*)
7. **Sukulati** (*Intangible*)

**DRAFT RESOLUTION CREATING THE CULTURAL INVENTORY OF THE
TUGUEGARAO CITY GOVERNMENT AND ENDORSING THE SAME TO THE
NATIONAL COMMISSION FOR CULTURE AND THE ARTS (NCCA) TO FORM
PART OF THE PHILIPPINE REGISTRY OF CULTURAL PROPERTY (PRECUP)**

WHEREAS, Section 2 of Republic Act No. 10066, otherwise known as the “National Cultural Heritage Act of 2009” mandates the protection, preservation, conservation, and promotion of the nation’s cultural heritage, its properties and histories, and the ethnicity of local communities;

WHEREAS, Section 14 (b) and (c) of same Act requires local government units (LGUs) to establish and maintain an inventory of local cultural property or registry, while Section 16 thereof directs the LGUs to document and preserve the traditional and contemporary arts present within its jurisdictions;

WHEREAS, in compliance thereto, Joint Memorandum Circular No. 2018-01 of the NCCA and the Department of the Interior and Local Government (DILG) dated October 9, 2018 is issued enjoining all LGUs to establish and maintain a local inventory of cultural property which shall form part of the PRECUP as supplemented by Joint Memorandum Circular No. 2021-001 dated May 7, 2023 stipulating the “Amended Guidelines on the Standardized Submission of Local Cultural Inventory under the PRECUP for the issuance of certificate of compliance to local government units”;

WHEREAS, included in the checklist in submitting a local cultural inventory is a Sangguniang Panlungsod resolution creating the cultural inventory of the LGU and endorsing the same to the NCCA to form part of the PRECUP;

WHEREAS, the City Tourism Office, recommended an inventory of cultural properties of the city preserving to wit:

1. **Cagayan Museum** (*Tangible Immovable*)
2. **Hammer** (*Tangible movable*)
3. **Horno** (*Tangible Immovable*)
4. **Mallattu ta Umo** (*Intangible*)
5. **Mappanday** (*Intangible*)
6. **Pinacanauan** (*Tangible Immovable*)
7. **Sukulati** (*Intangible*)

WHEREAS, the August Body firmly believes that the inclusion of the cultural inventory of Tuguegarao City in the PRECUP is one effective means of preserving these properties and the rich cultural and historical heritage of the place as well and in pursuance of the pertinent provisions of the National Cultural Heritage Act of 2009 and in compliance to the memorandum circulars issued for the implementation of the said law by local government units;

RESOLVED FURTHER, to endorse the cultural inventory of Tuguegarao City Government as herein created to the National Commission for Culture and the Arts to form part of the Philippine Registry of Cultural Property;

RESOLVED FURTHERMORE, to submit a copy of this resolution to the National Commission on Culture and Arts (NCCA) and the Department of the Interior and Local Government (DILG) and furnished the same to all other offices concerned by the office of the Local Chief Executive for their information and appropriate action.
