**RESOLUTION APPROVING AND ADOPTING THE MEMORANDUM OF AGREEMENT
 BETWEEN THE TUGUEGARAO CITY GOVERNMENT AND THE DEPARTMENT
 OF LABOR AND EMPLOYMENT RELATIVE TO THE GOVERNMENT
 INTERNSHIP PROGRAM (GIP) AND AUTHORIZING THE CITY
 MAYOR, HON. MAILA ROSARIO S. TING-QUE, TO SIGN FOR
 AND ON BEHALF OF THE TUGUEGARAO CITY
 GOVERNMENT THE SAID MOA**

WHEREAS, the Department of Labor and Employment RO2 (DOLE-RO2) through its Government Internship Program (GIP) Partner/Employer and the Tuguegarao City Government have agreed to enter into an agreement for the purpose of achieving the goals of the Government Internship Program of the DOLE, that is, to provide opportunities and engage young workers to serve the general public in government agencies/entities at the national and local levels;

WHEREAS, DOLE-RO2 as the implementer of the GIP undertakes to provide and assign the intended beneficiaries to the GIP Partner/Employer’s office to perform tasks and duties within those prescribed under Department Order No. 204/204-A, series of 2019 or other GIP Advisories;

WHEREAS, the Department of Labor and Employment is mandated to engage GIP Interns into public service by involving them in government programs, projects and services through the various GIP Partner Agencies;

WHEREAS, the DOLE provides program beneficiaries particularly the poor/indigent opportunity to demonstrate their knowledge and skills in the field of public service with the ultimate objective of attracting the best and brightest who want to pursue a career in government service, particularly in the fields and disciplines related to labor and employment;

WHEREAS, this partnership is vital to ensure the successful implementation of the said program and achieve its desired social outcomes;

WHEREAS, the following inclusions to the MOA under “*Responsibilities of the GIP Partner (2)*” were introduced during its deliberation in the plenary:


- a. Assists the DOLE and Partner-Agency’s personnel/staff
- b. Assists in the encoding of registrants in the PESO Employment System
- c. Assists in the profiling of child laborer, Persons with Disabilities and Senior Citizens in concerned barangays
- d. Assists public school and hospital personnel/staff
- e. Assists LGU personnel/staff
- f. Performs duties that are not highly technical in nature assigned by the government agency or GIP Partner

NOW, THEREFORE, RESOLVE, as it is hereby **RESOLVED**, to approve and adopt the Memorandum of Agreement between the Tuguegarao City Government and the Department of Labor and Employment relative to the Government Internship Program and to authorize the City Mayor, Hon. Maila Rosario S. Ting-Que, to sign for and on behalf of the City Government the said MOA.
