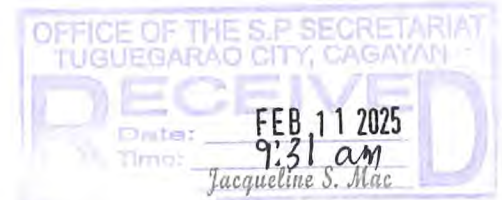

Dear *Presiding Officer and Members of the Sanggunian*:

This Office is respectfully reiterating our letter received by your level on **January 16, 2025**, which was supplemented by a referral dated February 7, 2025, relative to the approval of a resolution authorizing the City Mayor to request the Commission on Elections to exempt the identified social welfare and services projects from the prohibition on the release, disbursement, and expenditure of public funds during the campaign period.


As we have stated in our request, granting this exemption will allow the Tuguegarao City Government to continue its essential work and uphold our commitment to providing assistance to our constituents, especially those who belong to the marginalized and vulnerable sectors of the society.

Additionally, we would like to reiterate, at the risk of repetition, the urgency of this matter. The deadline for the submission of the request to COMELEC Law Department is today, **February 11, 2025**, and any late filing of the request shall result in its denial. For further guidance, we invite you to peruse the relevant provisions of COMELEC Resolution No. 11060.

Finally, please be advised that a personnel of the Office of the City Mayor is on standby to personally deliver the letter to the COMELEC Law Department, taking into account the extremely limited time remaining before the deadline.

Again, this matter is certified as **URGENT** pursuant to Article 107 of the Implementing Rules and Regulations of the Republic Act No. 7160, or the Local Government Code of 1991.

For your reference and perusal attached herein is a copy of Annex "A" and "B".

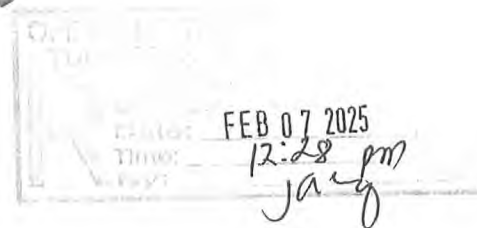
