CITY RESOLUTION NO. 152-10-2025

RESOLUTION APPROVING THE MEMORANDUM OF AGREEMENT BETWEEN THE TUGUEGARAO CITY GOVERNMENT AND DEPARTMENT OF TRADE AND INDUSTRY-REGIONAL OFFICE 02 RELATIVE TO THE ESTABLISHMENT OF A NEGOSYO CENTER IN TUGUEGARAO CITY AND GRANTING AUTHORITY TO THE CITY MAYOR, HON. MAILA ROSARIO S. TING-QUE, TO SIGN FOR AND ON BEHALF OF THE TUGUEGARAO CITY GOVERNMENT THE SAID MOA

WHEREAS, Section 455(b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, grants the Local Chief Executive the power to enter into contracts for and on behalf of the local government unit upon prior authorization by the Sangguniang Panlungsod;

WHEREAS, Republic Act No. 10644, otherwise known as the “Go Negosyo Act,” was enacted to promote job creation and inclusive growth in the Philippines. It mandates the establishment of Negosyo Centers in all provinces, cities and municipalities to provide support services to micro, small and medium enterprises;

WHEREAS, the Department of Trade and Industry (DTI), with support from LGUs and other partners, helps Micro Enterprises, Small Enterprises and Medium Enterprises (MSMEs) grow through Negosyo Centers that provide development services;

WHEREAS, Negosyo Centers provide programs and support in business development, management, marketing, human resources, and other key areas of enterprise growth;

WHEREAS, the LGU is responsible for providing office space, staff support and advocacy for the operations of the Negosyo Center. It also contributes funding by shouldering utility expenses such as electricity, water and internet. This financial support, though reasonable, requires proper planning and budgeting to sustain the Center’s continuous operations;

WHEREAS, it is necessary for DTI to enter into a Memorandum of Agreement (MOA) with the Tuguegarao City Government to make the MOA legally binding;

WHEREAS, the City Mayor, Hon. Maila Rosario S. Ting-Que, indorsed to the Tenth City Council the above-stated MOA and requested for an authority to sign for and on behalf of the Tuguegarao City Government the said MOA;

WHEREAS, after a deliberation in a committee meeting held for the said purpose, the Committee on Trade, Commerce and Industry found the request to be in order and beneficial to the concerned sector;

WHEREAS, after the approval of the concomitant committee report, the Tenth City Council during its 13th Regular Session held on September 30, 2025 deemed it proper and necessary to approve the herein resolution;





RESOLVED FURTHER, to furnish a copy of this Resolution to the Department of Trade and Industry-R02 for information and proper action.
