CITY RESOLUTION NO. 153A-10-2025

RESOLUTION DENYING THE REQUEST FOR RECONSIDERATION OF THE VARGAS SPORTS COLISUEM TO CONDUCT TWO (2) SPECIAL COCKFIGHTS PER WEEK

WHEREAS, the request for reconsideration of Mr. John Vargas Esquillo relative to the holding of two special cockfights per week was embodied in their request letter dated September 17,2025 which was discussed during the 11th regular session and was referred to the Committee on Games, Entertainment and Amusement;

WHEREAS, pursuant to Section 10(D) of the City Ordinance No. 32-08-2019 states that the City Mayor may issue permits for special cockfights, cock or stag derbies including cockfights via satellite participated in by cockers and breeders through invitations upon application duly approved by the Sangguniang Panlungsod through resolution 30-working days before the scheduled playdate and the City Ordinance also states that the authority to hold special cockfights or derbies and Barangay sponsored cockfights should always be covered by a Resolution of the Sangguniang Panlungsod and the Mayor's Permit;

WHEREAS, Section 3(C) of the Presidential Decree 449 states to remove and prevent excessive and unreasonable business operation and profit considerations in the management of cockpits and, instead preserve Philippine customs and traditions and thereby enhance our national identity;

WHEREAS, the Committee on Games, Amusement and Entertainment had previously approved the conduct of once-a-week special cockfights for Vargas Sports Coliseum for the Months of November and December;

WHEREAS, by virtue of the Committee Report No. 41-10-2025 of Committee on Games, Amusement and Entertainment recommended the submission of the matter requesting for reconsideration to the Plenary for its final consideration;

WHEREAS, after thorough discussion and consideration of the Tenth City Council, the majority of the members of the City Council voted for the denial of the request for reconsideration of the Vargas Sports Coliseum to hold two (2) special cockfights per week;

NOW, THEREFORE, RESOLVE, as it is hereby, RESOLVED, to deny the request for reconsideration of Vargas Sports Coliseum to conduct two (2) special cockfights per week.
