CITY RESOLUTION NO. 155-10-2025

**RESOLUTION APPROVING THE MEMORANDUM OF UNDERSTANDING BETWEEN
AND AMONG THE TUGUEGARAO CITY GOVERNMENT, PHILIPPINE DRUG
ENFORCEMENT AGENCY AND VARIOUS NATIONAL GOVERNMENT AGENCIES
AND STAKEHOLDERS FOR THE OPERATIONALIZATION OF BALAY SILANGAN
AND GRANTING AUTHORITY TO THE CITY MAYOR, HON. MAILA ROSARIO
S. TING-QUE, TO SIGN FOR AND ON BEHALF OF THE TUGUEGARAO CITY
GOVERNMENT THE SAID MOU**

WHEREAS, Section 455(b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, grants the Local Chief Executive the power to enter into contracts for and on behalf of the local government unit upon prior authorization by the Sangguniang Panlungsod;

WHEREAS, the City Mayor, Hon. Maila Rosario S. Ting-Que, has indorsed to the Tenth City Council the Memorandum of Understanding between and among the Tuguegarao City Government, Philippine Drug Enforcement Agency and various National Government Agencies and stakeholders for the operationalization of Balay Silangan and requesting an authority to enter into and sign the said MOU for and on behalf of the Tuguegarao City Government;

WHEREAS, the Memorandum of Understanding with the general purpose of implementing the Dangerous Drug Board (DDB) Regulation No. 2, Series of 2018 sets forth the guidelines for the reformation of drug personalities who voluntarily surrendered to authorities under the category of pushers, and those who undertook plea bargaining with court order to undergo reformation, and the provision of livelihood training, after-care and community/social re-integration programs through cooperation with the LGUs, the National Government and other stakeholders;

WHEREAS, the ownership, management and operation of the Balay Silangan project shall pertain exclusively to Tuguegarao City;

WHEREAS, there shall be a system of reporting or evaluation to be conducted on a date that will be set by the personnel assigned to and the Balay Silangan, without prejudice to the monitoring and evaluation activities of the Oversight Committee

WHEREAS, all parties shall undertake to provide necessary guidance and assistance for the successful implementation of the program;

WHEREAS, the Tenth City Council, during its 13th Regular Session held on September 30, 2025, found the terms and conditions of the MOU to be not contrary to law, public policy and public order, and beneficial to the constituents of Tuguegarao City;


NOW, THEREFORE, RESOLVE, as it is hereby **RESOLVED**, to approve the Memorandum of Understanding between and among the Tuguegarao City Government, Philippine Drug Enforcement Agency and various National Government Agencies and stakeholders relative to the operationalization of the Balay Silangan and anti-illegal drugs campaign and to grant authority to the City Mayor, Hon. Maila Rosario S. Ting-Que, to sign for and on behalf of the Tuguegarao City Government the said MOU.


RESOLVED FURTHER, to furnish copies of this Resolution to Philippine Drug Enforcement Agency and various National Government Agencies and stakeholders for their information.
