


RESOLVED FURTHER, to furnish a copy of this resolution to the family of the late Hon. Nestor R. Bueno for their information.



On motion of Hon. Ortiz and without any objection, **CITY RESOLUTION NO. 158-10-2025** was **APPROVED** under suspended rules.
