**A RESOLUTION UPDATING CITY RESOLUTION 02-10-2025 TO INCLUDE
THE CHAIRMANSHIP, VICE CHAIRMANSHIP AND MEMBERSHIP OF
HONORABLE JACKSON G. CARODAN IN VIEW OF THE DEMISE OF
HONORABLE LOPE B. APOSTOL, JR.**

WHEREAS, the Tenth City Council during its 1st Regular Session held on July 1, 2025 approved City Resolution No. 02-10-2025 *“A Resolution Approving the Composition of the Regular Committees of the Tenth City Council”*;

WHEREAS, Hon. Jackson G. Carodan took his oath of office as a City Councilor last October 2, 2025 replacing Hon. Lope B. Apostol, Jr. who peacefully joined His Creator last September 1, 2025;

WHEREAS, the untimely demise of Hon. Lope B. Apostol, Jr. created a vacancy in the chairmanship of the Committee on Trade, Commerce and Industry, vice chairmanship of the Committee on Cooperatives and Livelihood and Committee on Human Resources and Development and membership of the Committee on Public Information, Committee on Barangay Affairs, Committee on Slaughterhouse and Committee on Innovation, Digital Technology and Process Development;

WHEREAS, the above chairmanship, vice chairmanship and membership were declared vacant, thus, there is a need to fill them up following the Internal Rules of Procedure of the Tenth City Council;

WHEREAS, during the 14th Regular Session of the Tenth City Council held on October 7, 2025, the Body moved and decided that Hon. Carodan shall take over the chairmanship of the Committee on Trade, Commerce and Industry, vice chairmanship of the Committee on Cooperatives and Livelihood and Committee on Human Resources and Development, and membership of the Committee on Public Information, Committee on Barangay Affairs, Committee on Slaughterhouse and Committee on Innovation, Digital Technology and Process Development;

WHEREAS, in order to make the chairmanship and membership of Hon. Carodan formal and legal, there is a need to amend City Resolution No. 02-10-2025;



WHEREAS, the Tenth City Council during its 14th Regular Session held on October 7, 2025 approved the herein resolution;
