COMMITTEE REPORT NO.: 160 - 2024

SUBJECT:

Indorsement of the City Mayor, Hon. Maila Rosario S. Ting-Que, on the draft Memorandum of Understanding between the Tuguegarao City Government and University of Saint Louis Tuguegarao for the three planting project along Gunnacao Street corner Taft Street.

FINDINGS:

1. Prior coordination has already been undertaken by University of Saint Louis Tuguegarao through the Community Engagement and CICM Advocacies (CECA) Office with the City Environment and Natural Resources Office (CENRO) for the proposed tree planting project.
2. University of Saint Louis Tuguegarao requested partnership with the Tuguegarao City Government to adopt a certain area for logistical efficiency .
3. The identified planting area assigned by the Tuguegarao City Government through the City Environment and Natural Resources Office (CENRO) is along Pinacanauan na Tuguegarao Avenue (Gunnacao Street and Taft Street).
4. Tuguegarao City Government shall provide seedlings, technical expertise and technical assistance in planting techniques.
5. Initially, One Hundred (100) Narra seedlings will be planted on the identified planting area.
6. University of Saint Louis Tuguegarao shall submit activity/monitoring report every semester to City Government of Tuguegarao.
7. The Memorandum of Understanding upon expiration shall be renewable.

RECOMMENDATION:

Finding the terms and conditions of the Memorandum of Understanding to be in order and beneficial to the constituents of Tuguegarao City, herein Committees favorably recommend the passage of a Resolution approving the Memorandum of Understanding between the Tuguegarao City Government and the University of Saint Louis Tuguegarao for the tree planting project along Pinacanauan na Tuguegarao Avenue, and granting authority to the City Mayor, Hon. Maila Rosario S. Ting-Que to sign the same for and on behalf of the Tuguegarao City Government.
