CITY RESOLUTION NO. 163-09-2025

**RESOLUTION AMENDING CITY RESOLUTION NO. 502-09-2022 AUTHORIZING THE
CITY ADMINISTRATOR TO SIGN CHECKS DRAWN FROM THE ACCOUNT OF THE
TUGUEGARAO CITY GOVERNMENT WITH AMOUNTS NOT EXCEEDING P50,000.00
TO WITHOUT LIMITS AS TO THRESHOLD**

WHEREAS, the Ninth City Council in its 13th Regular Session held on October 03, 2022 approved City Resolution No. 502-09-2022 “*Resolution Granting Authority to the City Administrator, Mr. Juanito A. Calubaquib, to Sign Checks Drawn from the Account of the Tuguegarao City Government with Amounts Not Exceeding Fifty Thousand Pesos (P50,000.00);*”

WHEREAS, the referral pertaining to the “*Indorsement of the City Mayor, Hon. Maila Rosario S. Ting-Que, requesting for the amendment of City Resolution No. 502-09-2022 to authorize the City Administrator to sign checks drawn from the account of the Tuguegarao City Government with amounts not exceeding P50,000.00 to without limits as to threshold*” was endorsed to the Ninth City Council;

WHEREAS, the authority of the City Mayor to draw checks is extended to ensure that the Tuguegarao City Government can efficiently manage payments of obligations on behalf of the Tuguegarao City Government in the absence of the Local Chief Executive;

WHEREAS, Section 345 of the Local Government Code of 1991 does not specify a particular threshold or limit on the amount of money for which checks can be signed. Therefore, there is no legal restriction that would prevent the City Administrator from being authorized to sign checks of any amount, subject to compliance with all relevant financial and accountability procedures;

WHEREAS, the authority of the City Administrator shall only be limited to the signing of checks;

WHEREAS, there is a need for the passage of a resolution amending City Resolution No. 502-09-2022 authorizing the City Administrator to sign checks drawn from the account of the Tuguegarao City Government with amounts not exceeding P50,000.00 to without limits as to threshold;



WHEREAS, upon evaluation of the subject referral, the Joint Committee on Rules, Laws and Ethics and Committee on Appropriations and Ways and Means recommend for the passage of a Resolution Amending City Resolution No. 502-09-2022 *Authorizing the City Administrator to Sign Checks Drawn from the Account of the Tuguegarao City Government with Amounts not Exceeding P50,000.00 to Without Limits as to Threshold.*


