CITY RESOLUTION NO. 164-09-2025

**RESOLUTION APPROVING THE MEMORANDUM OF AGREEMENT BETWEEN THE
TUGUEGARAO CITY GOVERNMENT AND THE DEPARTMENT OF SOCIAL
WELFARE AND DEVELOPMENT RELATIVE TO THE TRANSFER OF SOCIAL
PENSION FUNDS TO THE LGU AND AUTHORIZING THE CITY MAYOR,
HON. MAILA ROSARIO S. TING-QUE, TO SIGN FOR AND ON BEHALF OF
THE TUGUEGARAO CITY GOVERNMENT THE SAID MOA**

WHEREAS, Chapter II, Section 17(b)(2)(iv) of the Local Government Code of the Philippines (Republic Act No. 7160) mandates the Municipality/City to provide Social Welfare Services which include programs and projects on child and youth welfare, family and community welfare, women's welfare, welfare of the elderly and disabled persons; community based rehabilitation programs for vagrants, beggars, street children, scavengers, juvenile delinquents and victims of drug abuse; livelihood and other pro-poor projects, nutrition services and family planning services;

WHEREAS, Section 2(h)(1) of Republic Act No. 11916 or the "An Act Increasing the Social Pension of Indigent Senior Citizens and Appropriating Funds Therefore, Amending for the Purpose Republic Act No. 7432", indigent senior citizens shall be entitled to a monthly stipend amount to not less than One Thousand Pesos (P1,000.00) to augment their daily subsistence and other medical needs;

WHEREAS, the Memorandum of Agreement is a requirement for the One-Time Transfer of the Social Pension for Indigent Senior Citizens (SPISC) for Calendar Year 2025 to the Local Government of Tuguegarao City;

WHEREAS, the first quarter pay-out shall be facilitated by the Department of Social Welfare and Development-Field Office 2 (DSWD-FO2) and the funds to be downloaded shall be for the second, third and fourth quarters of CY 2025 with an estimated amount of Sixty-Four Million, Seven Hundred Twenty-Eight Thousand Pesos (P64,728,000.00);

WHEREAS, the Memorandum of Agreement (MOA) between the Tuguegarao City Government and the DSWD outlines the terms and conditions for the transfer of funds, including roles and responsibilities, fund utilization, reporting and accountability measures to safeguard public resources;

WHEREAS, it is necessary to authorize the City Mayor, Hon. Maila Rosario S. Ting-Que, to sign the MOA for and on behalf of the Tuguegarao City Government to formalize this collaboration.


NOW, THEREFORE, RESOLVE, as it is hereby **RESOLVED**, to approve the Memorandum of Agreement between the Tuguegarao City Government and the Department of the Social Welfare and Development relative to the transfer of social pension funds to the LGU and to grant authority to the City Mayor, Hon. Maila Rosario S. Ting-Que, sign for and on behalf of the Tuguegarao City Government the said MOA.
