RESOLUTION DENYING THE REQUEST OF MR. VICENTE B. BUCAYU FOR A LETTER OF NO OBJECTION FOR A COCKFIGHTING OPERATION WITH LIVE STREAM AND TECHNOLOGY-BASED SYSTEM AT THE VARGAS SPORTS COCKPIT

WHEREAS, the Tuguegarao City Government, in compliance with national laws, local ordinances, and regulations governing cockfighting and related activities, evaluates all such requests to ensure public welfare, safety, and legal conformity;

WHEREAS, the City Administrator, Mr. Juanito A. Calubaquib, indorsed to the Tenth City Council the letter of Mr. Vicente B. Bucayu requesting for a Letter of No Objection for a Cockfighting Operation with Live Stream and Technology-Based System at the Vargas Sports Cockpit;

WHEREAS, the request was not properly endorsed by Vargas Sports Coliseum, consequently, the requestor, Mr. Bucayu, does not possess any existing contract or agreement with the Vargas Cockpit granting him the authority to conduct live-streaming activities at the said venue;

WHEREAS, after thorough discussion and deliberation, the committee has denied the request of Mr. Vicente B. Bucayu for a Letter of No Objection regarding the conduct of a cockfighting operation with live streaming and technology-based system at the Vargas Sports Cockpit based on the fact that the requestor, Mr. Bucayu, does not possess any existing contract or agreement with the Vargas Cockpit Coliseum granting him the authority to conduct live-streaming activities at the said venue;

NOW, **THEREFORE**, **RESOLVE**, as it is hereby **RESOLVED**, to deny the request of Mr. Vicente B. Bucayu for a Letter of No Objection for a Cockfighting Operation with Live Stream and Technology-Based System at the Vargas Sports Cockpit.
