CITY RESOLUTION NO. 167-10-2025

RESOLUTION APPROVING THE MEMORANDUM OF AGREEMENT BETWEEN AND AMONG THE TUGUEGARAO CITY GOVERNMENT, DEPARTMENT OF SCIENCE AND TECHNOLOGY-REGIONAL OFFICE 02 (DOST-R02), ISABELA STATE UNIVERSITY (ISU) AND UNIVERSITY OF SAINT LOUIS TUGUEGARAO (USLT) RELATIVE TO THE OPTIMIZATION OF DECISION SUPPORT SYSTEM FOR EFFECTIVE E-GOVERNANCE (ODeSSEE) AND GRANTING AUTHORITY TO THE CITY MAYOR, HON. MAILA ROSARIO S. TING-QUE, TO SIGN FOR AND ON BEHALF OF THE TUGUEGARAO CITY GOVERNMENT THE SAID MOA

WHEREAS, the Philippine Government is committed to adopting the United Nations Sustainable Development Goals into its National Development Plans and Policies, specifically SDG No. 11 on Sustainable Cities and Communities and other relevant SDGs;

WHEREAS, the City Mayor, Hon. Maila Rosario S. Ting-Que, has endorsed to the Tenth City Council the Memorandum of Agreement (MOA) between and among the Tuguegarao City Government, Department of Science and Technology-Region 02, Isabela State University and University of Saint Louis Tuguegarao relative to the Optimization of Decision Support System for Effective e-Governance (ODeSSEE) towards Strengthening Communities in Cagayan Valley and requesting an authority to enter into and sign the said MOA for and on behalf of the Tuguegarao City Government;

WHEREAS, the DOST-R02 is mandated as an implementing agency to provide specific and technological interventions to foster regional development;

WHEREAS, the Local Government Unit is committed to enhancing its economic infrastructure and promoting business opportunities through innovative technological solutions for the benefit of its constituents and potential investors;

WHEREAS, the Higher Education Institutions (HEIs)-ISU and USLT possess expertise in research, development, and technology transfer, and are mandated to extend generated technologies to target adopters, including LGUs;

WHEREAS, the DOST, LGU-Tuguegarao City, ISU and USLT desire to formally establish a collaborative partnership for the successful implementation of the ODeSSEE project towards Strengthening Communities in Cagayan Valley;

WHEREAS, the general objectives of the Project are to establish an integrated ODeSSEE dashboard for preemptive planning in the three cities of the Cagayan Valley (Cauayan City, Santiago City and Tuguegarao City) with the partner HEIs (Isabela State University-Echague and University of Saint Louis Tuguegarao), conduct capability-building with partner HEIs and LGUs City Disaster Risk Reduction Management Officers and Barangay Risk Reduction Management Officers using ODeSSEE and to assess the usability of ODeSSEE using ISO 25010 software quality standards;

WHEREAS, the technology/software was developed by Isabela State University for utilization by the concerned LGUs, with support from the academe in the training and capacity building on the system's usage, maintenance and administration;

WHEREAS, the Committee on Rules, Laws and Ethics, to which the matter was referred to, discussed and found the terms and conditions of the MOA to be in order, with merit and beneficial to the parties and recommended the following:

- 1. For the CDRRMO to designate a point person from its office to represent the Tuguegarao City Government for the proposed project;
- 2. Coordination with the Punong Barangays concerning their role in the project's implementation;
- 3. DOST shall coordinate with the CPDO on data pertaining to agricultural, commercial, and no-build zones and maintain close coordination with all concerned agencies regarding date profile gathering for integration process;
- 4. Maximize the use of existing technology from other authorized agencies in the formulation of the ODeSSEE Project;
- 5. Define all acronyms within the MOA for better understanding;
- 6. The City Legal Office shall coordinate with the concerned parties to clearly define the roles and responsibilities of the Tuguegarao City Government;
- 7. Include the Chair of the Committee on Peace and Order and Disaster Preparedness as one of the witnesses in the MOA; and,
- 8. DOST shall coordinate with the City Legal Office regarding the modification of the date of the project implementation

WHEREAS, the Tenth City Council, during its 14th Regular Session held on October 7, 2025, found the terms and conditions of the MOA to be not contrary to law, public policy and public order, and beneficial to the constituents of Tuguegarao City;

NOW, THEREFORE, RESOLVE, as it is hereby RESOLVED, to approve the Memorandum of Agreement between and among the Tuguegarao City Government, Department of Science and Technology-Region 02 (DOST-R02), Isabela State University and University of Saint Louis Tuguegarao and to grant authority to the City Mayor, Hon. Maila Rosario S. Ting-Que, to sign for and on behalf of the Tuguegarao City Government the said MOA.

RESOLVED FURTHER, to furnish a copy of this resolution to Department of Science and Technology-R02, Isabela State University and University of Saint Louis Tuguegarao for information.
