CITY RESOLUTION NO. 168-10-2025

RESOLUTION APPROVING THE TRIPARTITE MEMORANDUM OF AGREEMENT BETWEEN AND AMONG THE TUGUEGARAO CITY GOVERNMENT, COMMISSION ON POPULATION AND DEVELOPMENT (CDP) AND THE LIGA NG MGA BARANGAY-TUGUEGARAO CITY CHAPTER FOR THE IMPLEMENTATION OF THE REGISTRY OF BARANGAY INHABITANTS AND MIGRANTS (RBIM) AND GRANTING AUTHORITY TO THE CITY MAYOR, HON. MAILA ROSARIO S. TING-QUE, TO SIGN FOR AND ON BEHALF OF THE TUGUEGARAO CITY GOVERNMENT THE SAID MOA

WHEREAS, Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides LGUs the authority and responsibility to maintain updated demographic records that can support effective development planning, service provision and resource allocation;

WHEREAS, Section 37 of Republic Act No. 7279, otherwise known as the Urban Development and Housing Act of 1992, mandates the local government units (LGUs), in partnership with agencies like the Commission on Population and Development (CDP) to establish mechanisms to monitor population movements, specifically rural-to-urban and inter-urban migration;

WHEREAS, Department of the Interior and Local Government (DILG) Memorandum Circular No. 2008-144 instructs LGUs to strengthen their capacity to generate local data and regularly update the Registry of Barangay Inhabitants (RBI) which is essential for development planning and disaster response, however, it is noted that the prescribed data capture forms (RBI Forms A and B) do not include information on migration, thereby limiting the utility of the RBI in addressing issues related to population movement and urbanization;

WHEREAS, the City Mayor, Hon. Maila Rosario S. Ting-Que, has endorsed to the Tenth City Council the Memorandum of Agreement (MOA) between and among the Tuguegarao City Government, Commission on Population and Development (CDP) and the Liga ng mga Barangay-Tuguegarao City

Chapter and requested an authority to enter into and sign the said MOA for and on behalf of the Tuguegarao City Government;

WHEREAS, the CDP identified a need to implement a population movement tracking mechanism to efficiently inform planning, particularly in estimating the service requirements of the population;

WHEREAS, the Registry of Barangay Inhabitants and Migrants (RBIM) developed and initiated by CP to serve as a localized, practical, and cost-efficient data collection and management system at the barangay level enables the bottom-up consolidation and population information, enhances demographic planning, and integrates internal and external migration into the development agenda;

WHEREAS, the implementation of the RBIM at the barangay level involves a multi-stakeholder approach led by the City Population and Development Office and supported by the Planning and Development Office, Information Technology/Management Information System units and Barangay Secretaries;

WHEREAS, the CDP conducted an RBIM Training from July 01-15, 2025 which was attended by representatives from 49 Barangays of the City and other concerned employees of the Tuguegarao City Government;

WHEREAS, consisting of 562 barangays, Region II has made initial strides in RBIM implementation, with 183 barangays having undergone said training and 49 barangays actively implementing the system, and 34 LGU personnel trained on data processing spearheaded by CDP Region II, highlighting a growing institutional commitment to operationalizing RBIM;

WHEREAS, RBIM will be a pivotal advancement in placing people at the center of development by enhancing understanding of the interconnections between population and development variables, thereby supporting evidence-based planning, targeted program development, and effective policy information;

WHEREAS, this MOA seeks to institutionalize the partnership between and among the Tuguegarao City Government, the Commission on Population Development Region II and the Liga ng mga Barangay-Tuguegarao City Chapter to ensure the successful roll-out, implementation and sustainability of the RBIM system;

WHEREAS, the RBIM software was successfully downloaded to the computers of the barangays that participated in the training and the computers shall be the counterpart of the barangay;

WHEREAS, the Joint Committee on Rules, Laws and Ethics and Committee on Barangay Affairs, to which the matter was referred, discussed and recommended for the creation of a Technical Working Group (TWG) for the implementation of the RBIM in the city via an Executive Order; the creation of a Plantilla position for a City Population Officer under the City Health Office and to proceed with the proposed date of commencement as agreed upon by the committee members and the City Legal Office;

WHEREAS, the Tenth City Council, during its 14th Regular Session held on October 7, 2025, found the terms and conditions of the MOA to be not contrary to law, public policy and public order, beneficial to the constituents of Tuguegarao City;

NOW, THEREFORE, RESOLVE, as it is hereby **RESOLVED**, to approve the Tripartite Memorandum of Agreement between the Tuguegarao City Government, Commission on Population and Development and the Liga ng mga Barangay-Tuguegarao City Chapter for the implementation of the Registry of Barangay Inhabitants and Migrants (RBIM) and to grant authority to the City Mayor, Hon. Maila Rosario S. Ting-Que, to sign for and on behalf of the Tuguegarao City Government the said MOA.

RESOLVED FURTHER, to furnish copies of this resolution to Commission on Population and Development and the Office of the Liga ng mga Barangay-Tuguegarao City Chapter for information.

On motion of Hon. Baccay, duly seconded and without any objection, **CITY RESOLUTION NO. 168-10-2025** was **APPROVED**.



