The members of the joint committees convened and discussed the letter from Mr. Rodel Ordillos, Production Manager of RBC Cable Master System, regarding the renewal and continued coverage of Regular and Special Sessions of the City Council for the period July to December 2025.

The Committee respectfully submits this report to the esteemed body in session, outlining the actions taken, findings, and recommendations.

ACTIONS TAKEN:

The committee conducted a thorough discussion of Mr. Ordillo's letter regarding the renewal and continued coverage of Regular and Special Sessions of the City Council for the period July to December 2025.

Resource persons were invited to assist the committee during the deliberations.

FINDINGS:

1. The RBC Cable Master System has been a steadfast partner of the Tuguegarao City Government, consistently supporting its initiatives through effective and reliable information dissemination.

- 2. Its coverage and replay of the Regular and Special Sessions of the City Council via its community channel have played a vital role in keeping the citizens informed about key resolutions and ordinances enacted by the Sangguniang Panlungsod.
- 3. The continued broadcast of these sessions is essential to strengthening public awareness of legislative matters and ensuring that constituents remain engaged and updated on developmental issues and concerns.
- 4. With the transition to a new administration, there is a need to formalize the partnership through the approval of a new Memorandum of Agreement (MOA) via a resolution by the 10th City Council;

RECOMMENDATIONS:

- Passage of a corresponding resolution authorizing Hon. Rosauro Rodrigo G. Rusuello, City Vice Mayor, to sign the aforementioned Memorandum of Agreement on behalf of the Tuguegarao City Government.

The OFFICE OF THE VICE MAYOR and the SANGGUNIANG PANLUNSOD with postal address of City hall, Tuguegarao City, Cagayan, represented herein by HON. ROSAURO RODRIGO G. RESUELLO in his capacity as the Vice Mayor and Presiding Officer of the Sangguniang Panlungsod, hereinafter referred as the FIRST PARTY"; And

The RBC CABLE MASTER SYSTEM with postal address at #24 Luna Street, Tuguegarao City, Cagayan, represented by MRS. EVELYN J. CINENSE in her capacity as PRESIDENT hereinafter referred to as the SECOND PARTY";

WITNESSETH that:

WHEREAS, a weekly television program may be utilized as a means of disseminating information on the various activities, programs and projects of the office of the Vice Mayor and the Sangguniang Panlungsod of the City to keep the public in touch and abreast with the said programs and activities and to gather public support and promote the image of the City Government:

WHEREAS, the SECOND PARTY, is a popular television in the Province and has enough competence, efficiency and technical capacity to reach as far as the remotest Barangay of the City;

WHEREAS, the FIRST PARTY deems it necessary to continue the services of the SECOND PARTY in order to inform the public of its program, projects and activities;

NOW THEREFORE, in consideration of the foregoing premises and stipulation hereinafter set forth, the parties hereto agree and hereby agree as follows:

- That the Second Party shall devote ONE (1) hour a week for the airing or broadcasting of program dubbed as "THE REGULAR SESSION OF THE 10TH CITY COUNCIL" a television program which serves as an information dissemination endeavor of the Office of the Vice Mayor and Sangguniang Panlungsod which will telecast the regular and special sessions, of the Sangguniang Panlungsod, as well as the various programs, activities and projects of the aforementioned offices;
- That the Second Party shall undertake the coverage, editing and reproduction of every regular and special sessions, of the Sangguniang Panlungsod as well as the various programs, activities, plans and projects of the aforementioned offices.

- 3. That, in consideration of the above, the First Party shall pay the Second Party the amount of \$\mathbb{P}40,000.00\$ per month as production cost for a total of \$\mathbb{P}240,000.00\$ from July 2025 to December 2025.
- 4. That the First Party has the exclusive right of ownership over the media material-therefore the sale distribution and or production of said material by the Second Party is hereby prohibited, unless upon written authority given by the First party;
- 5. That this contract shall commence July 1, 2025 to December 31, 2025.
