CITY RESOLUTION NO. 170-10-2025

RESOLUTION APPROVING THE MEMORANDUM OF AGREEMENT BETWEEN THE TUGUEGARAO CITY GOVERNMENT AND THE DEPARTMENT OF FOREIGN AFFAIRS FOR THE ESTABLISHMENT OF THE DFA CONSULAR AFFAIRS OFFICE AND GRANTING AUTHORITY TO THE CITY MAYOR, HON. MAILA ROSARIO S. TING-QUE, TO SIGN FOR AND ON BEHALF OF THE TUGUEGARAO CITY GOVERNMENT THE SAID MOA

WHEREAS, the City Mayor, Hon. Maila Rosario S. Ting-Que, has endorsed to the Tenth City Council the Memorandum of Agreement (MOA) between the Tuguegarao City Government and the Department of Foreign Affairs requesting for an authority to enter into and sign the said MOA for the establishment of the DFA Consular Affairs Office for and on behalf of the Tuguegarao City Government;

WHEREAS, the Tuguegarao City Government is the legitimate owner of the building located at the Tuguegarao City Hall Compound, Tuguegarao City;

WHEREAS, the Department of Foreign Affairs, in its desire to bring the government services closer to the people, has expressed to partner with the City Government to ensure the public of a more efficient and convenient delivery of passports and other consular services;

WHEREAS, the DFA-CO and Tuguegarao City Government agree to renew the MOA and maintains the rent-free use of the allocated building premises which was constructed according to the agreed specifications and adheres to mutually acceptable terms and conditions for the benefit of the DFA's clientele and the general public;

WHEREAS, the Department of Foreign Affairs has been occupying a portion of the Tuguegarao City Hall building and the office space previously vacated by the Philippine Statistics Authority (PSA);

WHEREAS, the term of the rent-free hosting of the DFA shall be for the period of five (5) years, commencing on November 26, 2025 until November 25, 2030;

WHEREAS, the terms and conditions of the subject MOA are not contrary to law, public policy and public order, and are beneficial to both parties;



NOW, THEREFORE, RESOLVE, as it is hereby **RESOLVED**, to approve the Memorandum of Agreement between the Tuguegarao City Government and the Department of Foreign Affairs for the establishment of the DFA Consular Affairs Office and to grant authority to the City Mayor, Hon. Maila Rosario S. Ting-Que, to sign for and on behalf of the Tuguegarao City Government the said MOA with the Department of Affairs represented by Undersecretary for Administration Maria Theresa B. Dizon-De Vega.

RESOLVED FURTHER, to furnish a copy of this Resolution to the Department of Foreign Affairs for information and proper action.
