RESOLUTION APPROVING THE MEMORANDUM OF AGREEMENT BETWEEN THE TUGUEGARAO CITY GOVERNMENT AND INTEGRATED BAR OF THE PHILIPPINES CAGAYAN CHAPTER RELATIVE TO THE ESTABLISHMENT OF A LEGAL AID PROGRAM AND GRANTING AUTHORITY TO THE CITY MAYOR, HON. MAILA ROSARIO S. TING-QUE, TO SIGN FOR AND ON BEHALF OF THE TUGUEGARAO CITY GOVERNMENT THE SAID MOA

WHEREAS, the Supreme Court in A.M. No. 22-11-01-SC (Rules in the Unified Legal Aid Service) requires the rendering of pro bono legal aid services by non-exempt members of the bar as part of their professional responsibility;

WHEREAS, the City Mayor, Hon. Maila Rosario S. Ting-Que, has endorsed to the Tenth City Council the Memorandum of Agreement (MOA) between the Tuguegarao City Government and Integrated Bar of the Philippines relative to the establishment of a Legal Aid Program;

WHEREAS, the IBP Cagayan Chapter President, Cliff John C. Bautista, in his letter dated August 8, 2025 to the Honorable City Mayor, expressed their intent to formalize a partnership with the Tuguegarao City Government through a MOA which aims to establish a Legal Aid Program that will provide free assistance, legal counselling, representation and other related services to qualified residents of Tuguegarao City;

WHEREAS, the IBP Cagayan Chapter is one of the most productive and active IBP Chapters in Luzon Area;

WHEREAS, the Committee on Rules, Laws and Ethics, to which the matter was referred to, discussed and found the terms and conditions of the MOA to be in order, with merit and beneficial to both parties and to the constituents of Tuguegarao City;

NOW, THEREFORE, RESOLVE, as it is hereby **RESOLVED**, to approve the Memorandum of Agreement between the Tuguegarao City Government and Integrated Bar of the Philippines Cagayan Chapter relative to the establishment of a Legal Aid Program and to grant authority to the City Mayor, Hon. Maila Rosario S. Ting-Que, to sign for and on behalf of the Tuguegarao City Government the said MOA.
