RESOLUTION APPROVING THE REQUEST OF MS. ELIZABETH G. DUPAYA TO HOLD SPECIAL DERBIES ON MAY 06, 08, 13, 15, 20, 22, 27 AND 29, 2024 AND DENYING THE APPROVAL OF THE REQUESTED SCHEDULE OF SCPECIAL DERBY ON MAY 01, 2024

WHEREAS, Hon. Maila Rosario S. Ting-Que indorsed to the Ninth City Council the request of the Dupaya Recreation Center to hold special derbies on various dates of May 2024;

WHEREAS, Section 10(D) of City Ordinance No. 32-08-2019 states that the City Mayor may issue permits for special cockfights, cock or stag derbies including cockfights via satellite participated in by cockers and breeders through invitations upon application duly approved by the Sangguniang Panlungsod through resolution of 30-working days before the scheduled playdate;

WHEREAS, after the discussion of the said request, the committee approved the following scheduled playdates:

May 06, 2024	May 20, 2024
May 08, 2024	May 22, 2024
May 13, 2024	May 27, 2024
May 15, 2024	May 29, 2024

WHEREAS, the committee did not approve May 01, 2024 in light of the celebration of the National Labor Day;

WHEREAS, the Dupaya Recreation Center, Inc. should use traditional betting during its special derbies;

WHEREAS, by virtue of Committee Report No. 104-2024 adopted during the 83rd Regular Session of the Sangguniang Panlungsod, the Committee on Games, Amusement and Entertainment recommended the approval of the request of Dupaya Recreation Center, Inc. to hold derbies on May 06, 08, 13, 15, 20, 22, 27 and 29, 2024 only.

NOW, THEREFORE, RESOLVE, as it is hereby **RESOLVED**, to approve the request of Ms. Elizabeth G. Dupaya to hold special derbies on May 06, 08, 13, 15, 20, 22, 27 and 29, 2024 only and to deny the approval of the requested schedule of special derby on May 01, 2024.
