# CITY RESOLUTION NO. 172-09-2025

RESOLUTION APPROVING THE REQUEST OF DUPAYA RECREATION CENTER, INC. TO HOLD HACKFIGHTS ON MAY 5, 7, 14, 19, 21 AND 28, 2025 ONLY AND DENYING THE REQUEST OF SCHEDULED PLAYDATE ON MAY 12, 2025

WHEREAS, the City Mayor, Hon. Maila Rosario S. Ting-Que, indorsed to the Ninth City Council the request of the Dupaya Recreation Center, Inc. to hold special cockfights on various dates for the Month of May 2025;

WHEREAS, Section 10(D) of City Ordinance No. 32-08-2019 states that the City Mayor may issue permits for special cockfights, cock or stag derbies including cockfights via satellite participated in by cockers and breeders through invitations upon application duly approved by the Sangguniang Panlungsod through resolution of 30-working days before the scheduled playdate and that the authority to hold special cockfights or derbies and Barangay sponsored cockfights should always be covered by a Resolution of the Sangguniang Panlungsod and the Mayor's Permit;

WHEREAS, the holding of hackfights must adhere to strict compliance of City Ordinance No. 32-08-2019 and failure of the Dupaya Recreation Center, Inc. to secure special permit from the Office of the City Mayor in the conduct of special cockfights shall cause the recall of the resolution approving the conduct of such hackfights;

WHEREAS, after the discussion of the said request, the Committee approved the scheduled playdates on May 05, 07, 14, 19, 21 and 28, 2025 only and denying the request of scheduled playdate on May 12, 2025 since this is Election Day;

WHEREAS, Committee Report No. 76-2025 of the Committee on Games, Entertainment and Amusement recommending the approval of the request of the Dupaya Recreation Center, Inc. to hold hackfights on May 05, 07, 14, 19, 21 and 28, 2025 only and denying the request of scheduled playdate on

May 12, 2025 was adopted during the 128th Regular Session of the Sangguniang Panlungsod held on March 03, 2025;

WHEREAS, the special permit should be acquired ten (10) days prior to the conduct of the special cockfights, copy furnished the Office of the SP Secretariat.

**NOW, THEREFORE, RESOLVE,** as it is hereby **RESOLVED**, to approve the request of the Dupaya Recreation Center, Inc. to hold hackfights on May 05, 07, 14, 19, 21 and 28, 2025 only and denying the request of scheduled playdate on May 12, 2025.
