**CITY RESOLUTION NO. 174-10-2025**

**RESOLUTION APPROVING THE MEMORANDUM OF AGREEMENT BETWEEN  
THE TUGUEGARAO CITY GOVERNMENT AND DR. MA. ENRICA M. PATTAGUAN-  
BOSITO, OBSTETRICS AND GYNECOLOGY, VISITING CONSULTANT/SPECIALIST  
AT THE TUGUEGARAO CITY PEOPLE'S GENERAL HOSPITAL**

**WHEREAS**, Section 22(c) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, grants the power to the Local Chief Executive to enter into contracts on behalf of the local government unit with prior authorization by the Sanggunian concerned;

**WHEREAS**, the referral "Indorsement of the City Mayor, Hon. Maila Rosario S. Ting-Que, on the draft Memorandum of Agreement between the Tuguegarao City Government and Dr. Ma. Enrica M. Pattaguan-Bosito, Obstetrics and Gynecology, Visiting Consultant/Specialist at the Tuguegarao City People's General Hospital" was endorsed to the Tenth City Council;

**WHEREAS**, the Ninth City Council in its 19<sup>th</sup> Regular Session held on November 22, 2022 approved City Ordinance No. 61-09-2022 titled "*An Ordinance Granting Continuing Authority to the City Mayor for and on Behalf of the Tuguegarao City Government to Enter into a Memorandum of Agreement with Visiting Consultants/Specialists of Tuguegarao City People's General Hospital*";

**WHEREAS**, the services of Dr. Ma. Enrica M. Pattaguan-Bosito, Obstetrics and Gynecology, as Visiting Consultant/Specialist would significantly assist in the delivery of basic healthcare services to the patients in the hospital and would also mean additional income for the Tuguegarao City People's General Hospital;

**WHEREAS**, in order to make the contract legally binding, it is necessary to approve the Memorandum of Agreement between the Tuguegarao City Government and Dr. Ma. Enrica M. Pattaguan-

Bosito, Obstetrics and Gynecology, Visiting Consultant/Specialist at the Tuguegarao City People's General Hospital;

**WHEREAS**, the Tenth City Council in its 15<sup>th</sup> Regular Session held on October 14, 2025 deemed it proper and necessary to approve the herein resolution;





