WHEREAS, the Professional Regulation Commission (PRC) has released the results of the Physician Licensure Examination conducted on October 2025 in different testing centers nationwide including the National Capital Region, Baguio, Cagayan de Oro, Cebu, Davao, Iloilo, Legazpi, Lucena, Pampanga, Rosales, Tacloban, Tuguegarao, and Zamboanga;

WHEREAS, with the release of the names of the 4,570 successful examinees, the Professional Regulation Commission (PRC) announced the top ten performing schools wherein Saint Paul University–Tuguegarao ranked number four with 50-99 examinees with at least 80% passing percentage in the October 2025 Physician Licensure Examination;


