SUBJECT:

Indorsement of the City Mayor, Hon. Maila Rosario S. Ting-Que, on the letter of Ms. Elizabeth G. Dupaya requesting to hold special derbies on various dates of August, 2024.

FINDINGS:

1. Hon. Maila Rosario S. Ting-Que indorsed to the Ninth City Council the request of the Dupaya Recreation Center to hold special derbies on various dates of August 2024.

2. Section 10, Paragraph D of City Ordinance No. 32-08-2019 states that the City Mayor may issue permits for special cockfights, cock or stag derbies including cockfights via satellite participated in by cockers and breeders through invitations upon application duly approved by the Sangguniang Panlungsod through a resolution **30-working days** before the scheduled playdate.
3. Upon deliberation of the said request, the joint committee approved the following scheduled play dates to hold special derbies:

August 5, 2024;
August 7, 2024;
August 12, 2024;
August 14, 2024;
August 15, 2024;
August 16, 2024
August 19, 2024;
August 21, 2024; and
August 28, 2024; only

However, the joint committee did not approve August 26, 2024 from the list of the said scheduled play dates due to the celebration of National Heroes Day.


4. The Dupaya Recreation Center, Inc. should adhere to traditional betting during its Special Derbies.

RECOMMENDATION:


