WHEREAS, Hon. Jackson G. Carodan took his oath of office as a City Councilor last October 2, 2025 replacing Hon. Lope B. Apostol, Jr. who peacefully joined His creator last September 1, 2025;

Parallag, Supervising Administrative Officer, relative to the designation of a new representative to the Human Resource Merit Promotion and Selection Board was referred to the Committee on Human Resources and Development:
