CITY RESOLUTION NO. 187-09-2025

RESOLUTION APPROVING THE MEMORANDUM OF AGREEMENT BETWEEN THE TUGUEGARAO CITY GOVERNMENT AND DR. HOMER BAQUIRAN, ANESTHESIOLOGIST, VISITING CONSULTANT/SPECIALIST AT THE TUGUEGARAO CITY PEOPLE'S GENERAL HOSPITAL

WHEREAS, Section 455(b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, grants the Local Chief Executive the power to enter into contracts for and on behalf of the local government unit upon prior authorization by the Sangguniang Panlungsod;

WHEREAS, the City Mayor, Hon. Maila Rosario S. Ting-Que, has requested for an authority to sign for and on behalf of the City Government, the Memorandum of Agreement between the Tuguegarao City Government and Dr. Homer Baquiran, Anesthesiologist, Visiting Consultant/Specialist of the Tuguegarao City People's General Hospital;

WHEREAS, the Ninth City Council in its 19th Regular Session held on November 22, 2022 approved City Ordinance No. 61-09-2022 titled "*An Ordinance Granting Continuing Authority to the City Mayor for and on Behalf of the Tuguegarao City Government to Enter into a Memorandum of Agreement with Visiting Consultants/Specialists of Tuguegarao City People's General Hospital*";

WHEREAS, the services of Dr. Baquiran as Visiting Consultant/Specialist, is needed for the continuous licensing of the clinical laboratory of the Tuguegarao City People's General Hospital so the latter can render his services in the said hospital;

WHEREAS, it is necessary to approve the Memorandum of Agreement between the Tuguegarao City Government and Dr. Homer Baquiran, Anesthesiologist, Visiting Consultant/Specialist of the Tuguegarao City People's General Hospital;


WHEREAS, the Ninth City Council, during its 130th Regular Session held on March 18, 2025 approved the said Memorandum of Agreement.


On motion of Hon. Callangan and without any objection, **CITY RESOLUTION NO. 187-09-2025** was **APPROVED**.
