SUBJECT:

Letter of the City Mayor, Hon. Maila Rosario S. Ting-Que, on the final set of programs for the 2024 PAVVURULUN AFI FESTIVAL from August 01-16, 2024

FINDINGS:

- Tuguegarao City will be celebrating its 300th Annual Patronal Fiesta "PAVVURULUN AFI FESTIVAL 2024" in honor of its Patron Saint, San Jacinto de Polonia on August 1-16, 2024.
- In observance of the annual fiesta celebration, the Tuguegarao City Government has lined up various activities to commemorate the history and life of Tuguegaraoeños, promote the rich and distinct cultural heritage of the city, and entertain and foster oneness among Tuguegaraoeños.
- 3. Ms. Luthgarda Bingcang, City Budget Officer, informed the Body that the budget for the 300th Patronal Fiesta Celebration amounts to Twenty-Three Million Three Hundred Thirty-One Thousand Five Hundred Eleven Pesos (P23,331,511.00), Twenty Million of which (P20,000,000.00) was appropriated in the Annual Budget for CY 2024 for Ibanag Cultural Heritage Development, and the remaining amount shall be sourced out from the Trust Fund.
- 4. The different programs of work were reviewed by the committee. A number of department heads/program managers especially of new activities presented their programs of work.
- 5. As per information from Mr. Buenaventura Lagundi, City Treasurer, there is a donation of more than P1 Million Pesos for the patronal fiesta celebration.
- 6. Hon. Callangan raised her objection to the funding of Two Hundred Fifty Pesos (P250,000.00) for the composition of the 300 years theme song to be composed by Direk Alto Del Rosario and her suggestion for a Tuguegaraoeño to compose such.

AMENDMENTS TO COMMITTEE REPORT NO. 188-2024 OF THE COMMITTEE OF THE WHOLE ON THE FINAL SET OF PROGRAMS FOR THE PAVVURULUN AFI FESTIVAL 2024

FOR THE FINDINGS:

- 1. To include the collection of participation fee for the conduct of the Trade Fair and Food Fair shall be authorized through a resolution.
- 2. To comply with City Ordinance No. 46-2018, "AN ORDINANCE EXPANDING SECTION 192 AND 193 OF CITY ORDINANCE NO. 058-2017 THEREBY REGULATING THE SINGLE USE OF PLASTIC CELLOPHANE AND SANDO BAGS AS PACKAGING MATERIALS, AND THE USE OF STRAWS AS MATERIAL FOR CONSUMPTION OF BEVERAGES, AND UTILIZATION OF POLYSTYRENE, COMMONLY KNOWN AS STYROFOAM, FOR FOOD AND BEVERAGES CONTAINERS IN THE CITY OF TUGUEGARAO AND PRESCRIBING PENALTIES THEREOF," especially for the Trade Fair and Food Fair shall be followed.
- 3. To adopt" AFI Festival 2024" pursuant to City Ordinance No. 37-2017, "AN ORDINANCE ADOPTING THE OFFICIAL NAME OF THE CITY PATRONAL FIESTA CELEBRATION AS "AFI FESTIVAL."

FOR THE RECOMMENDATIONS:

- 1. To replace the use of "PAVVURULUN AFI FESTIVAL 2024" to "300th TUGUEGARAO CITY ANNUAL PATRONAL FIESTA 2024" to jibe with the approved resolution.
- 2. To include the passage of a separate resolution authorizing the collection of participation fee for the Trade Fair and Food Fair.
