WHEREAS, it is the intention of the Local Government of Tuguegarao to give the people full opportunity to commemorate the Charter Day;




RESOLVED FURTHER, to furnish a copy of this Resolution to Executive Secretary Lucas P. Bersamin for his information and appropriate action.


